Sir,

I, Ashis Das, Son of Late Dwijendra Mohan Das, resident of Patel Road, Siliguri Municipal Corporation Ward No. II, Post Office and Police Station Pradhan Nagar, District Darjeeling, would like to inform you that to day at about 1.45 PM I was standing at the extreme end of the service road in front of "Hotel Heritage", Pradhan Nagar Siliguri. All and sudden one Toto being its Registration No. WB73 F 5700 reversed in high speed and dashed me and due to such incident I sustained injury. Being asked the Driver of the said Toto threatened me saying that they are the local person of the area and driver of local toto stand and it is his wish how he drive the vehicle. The said Driver also threatened me saying that if I lodge any complain to any one then he shall take necessary measure with his men showing their muscle power.

Sir, I am not physically fit due to the various ailments and being a senior citizen I have/had no strength to resist the said Toto Driver, therefore it is humbly prayed to take necessary legal action against the said Driver so that no one can suffer/injure due to his such rash and negligent driving.

Sir, it is needful to mention here that the area beside and in front of "Hotel Heritage", in fact the entire Patel Road is always congested due to the illegal parking and stand of various vehicle including the "Toto Stand", more or less in regular basis this type of unwanted incident took place.

Hope you will look into the matter seriously and take necessary legal action and enter into the matter in your General Diary Entry Book for the ends of justice.
