I, Smt. Juspina Oraon, W/o Lt. Anil Oraon, resident of Bagdogra Tea Estate, Kadopani, P.O & P.S- Bagdogra, Dist- Darjeeling, Pin No- 734014, West Bengal, would like to lodge a formal complaint regarding a tragic accident that occurred on 02/12/2025 at approximately between 4:00 AM to 6:00AM when my husband Mr. Anil Oraon (now deceased) had gone for his as usual morning walk.

That on the said date and time my husband body was found on the road National Highway (NH 31) at Bagdogra Tea Estate, Kadopani, near Track Marshal Military camp a vehicle on the same route travelling from Kolkata/Bihar side towards Bihar More has struck my husband resulting to his on the spot death upon receiving severe injuries.

That thereafter, around 6:00 AM with the help of local residents and the police present at the spot, they took my husband body to North Bengal Medical College for Post-mortem.

That therefore, I humbly request you kindly take serious note of this incident, identify the driver and vehicle responsible for the reckless act, and ensure that the person responsible is brought to justice for their careless and negligent actions.
