Sir,

I, Mr Prashanta Kumar Mahato, DE&SM Milanpally CCC , do hereby lodge this complaint to the effect that today (27.11.2025) at 12:29 pm regarding theft of electric energy found during routine inspection by myself along with Mr. Bijay Lakra, S.E.(S&LP), Mr. Bhaben Roy, SO, S&LP, Darjeeling Region, and other technical personnel had been to the spot at **Mandeep Apartment, Bidyapith Road** in the house of **Mr. Rajdip Basu**. After issuing notice to him, we check the departmental meter (No.: L4243308 and ID No: 401373698) found that one domestic connection was issued to him.

On physical inspection, it has been detected that said **Mr. Rajdip Basu** has been using domestic electricity connection (Consumer ID: 401373698) at temporary disconnected premises. The line was disconnected on 28.05.2025., due to outstanding dues of Rs.2517. Consumer re-connected line illegally using 32 amp fuse unit.

He did this intentionally, motivatedly with malafied intention for his wrongful gain.

As **Mr. Rajdip Basu** has committed an offence, punishable under section 135(1) (a) of Electricity Act, 2003. So, I, prepared inspection memo and seizure list by seizing the meter in- question along fuse unit in presence of witnesses and supplied copies of it to the representatives of the premises owner. The connected load of meter is 3.52 kVA & final reading of meter is found 16002 ckwh. So, it is requested to start a case u/s 135(1)(a) and 138(1)(b) of Electricity Act 2003 (Amendment Act 2007) against **Mr. Rajdip Basu** and arrange for its investigation.
