Sir,

With due respect I am producing herewith one (01) arrested accused person namely Sekhar Das (34) s/o Nirmal Das of Noukaghat more Ps NJP dist Jalpaiguri (Not verified) under proper arrest memo along with 50 white plastic packet of detergent each packet containing 50 kg.

I SI Md. Sanaullah presently attached with NJP PS, Siliguri Police Commissionerate under your kind control beg to state that today on 23/12/2025 I received a secret source information that one person is standing at Noukaghat more with huge quantity of detergent and waiting for a vehicle for its disposal, Accordingly I informed the matter to you and noted in GDE vide NJ.P PS GDE No 1152 Dated 23-12-2025 and left for Noukaghat for verify the matter. I along with C/1520 Samir Adhikary, NVF 136 Kajal Roy. After reaching Noukaghat More I found the above noted person was standing at Noukaghat with huge quantity of white colour plastic bag. After seeing the police party the above noted person tries to flee away from the spot but somehow we managed to detain him. On being asked the apprehended person disclosed his name and address mentioned above and admitted that he was carrying the said white colour bags somewhere from Siliguri area and send to Assam for selling the same illegally for his wrong full gain. On asked, he failed to produce any papers in support of carrying the said bags. It is crystal clear and reason to believe that the above noted accused person carrying the said bags with full of detergent illegal means or by stolen means for dishonestly dispose the same to earn huge money illegally.

Accordingly, I seized the above noted 50 white plastic packet of detergent each packet containing 50 kg. from his possession under proper seizure list and arrested him under proper memo of arrest after observing all the formalities of arrest as well as ground of arrest is duly communicated with him. The process of seizure was made in between 16.45 hrs to 17 .05 hrs on 23.12.2025.

Hence, I pray to you considering the offence the specific case may kindly be started against the arrested accused person namely Sekhar Das(34) s/o Nirmal Das of Noukaghat more Ps NJP dist Jalpaiguri (Not verified) and others under proper section of law and arrange for its investigation.
