Respected Sir,

I, SI Hiru Kanti Sarkar presently posted as Officer – In – Charge, Panitanki Town Out Post under your kind control beg to state that on 22.12.2025 at 11.55 hrs I received an information that approx 70 to 80 leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization, North Bengal will hold rally and demonstration and "Protest" against the brutal murder of Hindu laborer Dipu Chandra Das in Bangladesh. Further it came under light that the leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization, will assemble at Bagha Jatin Park, Siliguri and from their they will come at the Panitanki More and will demonstrate in front DU Digital Global Pvt. Ltd. office at International Market, Sevok Road, Siliguri as the company provides help for getting visa to abroad specially for Bangladesh. Accordingly I diarized the matter vide Panitanki TOP GDE No. 513 Date: 22.12.2025 and informed the same to you and superiors and also Police arrangement has been made on the score.

At around 12.30 hrs the leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization assembled at Baghajatin Park, Siliguri and at around 13.00 hrs they started a rally along with 70 to 80 leaders and supporters. At around 14.00 hrs the rally reached at Panitanki More through Venus More, Bidhan Road carrying banners and flags of the organization. On arrival at Panitanki More under Siliguri PS they started raising slogans against the extremists of Bangladesh as well as the present government and chief of the government of Bangladesh. In between this the supporters who are raising ante Bangladesh slogans became agitated and started proceeding towards the office DU Digital Global Pvt. Ltd. office at International Market, Sevok Road, Siliguri with an intension of siege the office as the provides help to the get-visa to Bangladesh.


Seeing the supporters assembled in front of the office of DU Digital Global Pvt. Ltd. situated in a commercial building complex and just adjacent to the busy Sevok Road as a result the flank of the Sevok Road headed towards Bhaktinagar got stacked which causes obstruction in the free flow of traffic. In the mean time the agitated leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization started threatening the officials of DU Digital Global Pvt. Ltd and started shouting and started planning to

destroy the office. Considering the gravity of the situation I along with my other officers and force deployed at the spot Intervene and started make them understand that the DU Digital Global Pvt. Ltd is a private company and they provides help to the Individuals to obtain visa for abroad including Bangladesh and this company is neither belongs to Bangladesh nor an organization of Bangladesh government and they provide service to the public by maintaining all formalities.


Hearing my words some of the leaders and supporters agreed but some continuing demanding to close the company by violating the direction of me i.e. an on duty public servant. Seeing the situation I then strongly direct the to move on and described them their act creating in- convenience to the public who are coming to the market complex for their business and official purpose and also they has no write to stop a company running their business legally. Also they assembled without any permission and their program impedes the free flow of traffic. After some time at around 15.30 hrs I finally make them understand and able to remove all of the 70 to 80 leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization, North Bengal moved from the place and traffic flow get normal.

Over this facts and circumstances I pray before that a specific case may kindly be Initiated against 70 to 80 leaders and supporters of "Hindu Jagaran Mancha" Siliguri Town Organization, North Bengal for illegally and unlawfully assembled Infront of International Market, Sevok Road, Siliguri under the jurisdiction of Siliguri PS for assemble unlawfully, blocking the free flow of traffic, obstruct and restraining and disobeying the direction of public servant and also to threatening and using ill-wards to the official of the company and arrange for it's investigation.
