Subject: Written Complaint Against against Abhishek Paswan, Sachin Paswan, and Bhago Paswan for physical assault and abuse.

Respected Sir/Madam,

I, Ram Vilash Sahani, S/O. Sundar Sahani, resident of Jyotinagar Colony, Ward No. 20 of SMC, P.O & P.S: Siliguri, Dist: Darjeeling, West Bengal, Pin Code: 734001, wish to inform you that I run a small pan shop outside my house at the aforementioned address with my elder son.

Today morning, on 21-12-2025, a local resident named Abhishek Paswan, S/O Arbind Paswan, who comes regularly to my shop, I requested him to clear his pending dues for items like khaini and cigarettes, he became furious and started abusing me and became violent and abused me of being. Immediately after, his two brothers, Sachin Paswan and Bhago Paswan, came to the shop and they all started brutally assaulting me and throwing my shop goods here and there. With the intention to kill me, they beat me mercilessly with fists and blows, specifically targeting my face, which caused a serious injury and heavy bleeding from my nose. While they were assaulting me, they also threatened to kill me and my son and warned that they would burn down my shop if I dared to ask for the money again or informed the police.

They also threatened me that I have to give them pan, biri, guthka free whenever they come to my shop. Subsequently, I was heavily injured and with the intervention of local residents, I was taken to the Siliguri District Hospital for treatment.

I am in great fear for my life and my family's safety. I request you to kindly take strict legal action against Abhishek, Sachin, and Bhago Paswan and arrest them immediately.
