Sir,

I, Amit Malakar, Son Of Nibaran Malakar, resident of East Ghogomali, Eastern bypass Bottola, P.O- Ghogomali, P.S – Bhaktinagar, District- Jalpaiguri, Pin-734006, would like to draw your sincere attention over the below stated facts and circumstances :-


That, on 10-12-2025, at around 1 pm to 1.30 pm while I was in my chamber just beside Ashighar outpost suddenly out of my utter surprise I found Mr. Kundu the owner of Kundu Bastralaya located at Sikha Road, Ashighar, along with the present committee members of the Ashighar Bazar Committee entered in to my Chamber along with other hooligans armed with sharpened weapons and steel rods. Furthermore after entering my chamber they forcefully ousted my client who came for consultation in my chamber. Thereafter when I objected against their illegal deeds they threatened me to break my head by hitting with an iron rod and threatened me to leave my chamber at once by vacating the premises. I repeatedly uttered that a specific civil suit is pending before the Ld. Civil Judge Junior Division Court at Jalpaiguri vide. Title Suit No. 722/2025 and the Ld. Court was pleased to pass an interim order in my favour. Thereafter I somehow shouted for help and as the police station is less than 100 meters away from my chamber, these miscreants immediately left my chamber and threatened me that they are politically well connected people and they do not fear of violating courts order. That immediately after they said Mr Kundu of Kundu Bastralaya and his hooligans companions some members of Ashighar Babshayi Samity went out of my chamber the said owner namely Gobinda Das along with his son in law name unknown, who is a resident of Sanghati More along with his wife (Manju Das), daughter (Unknown) entered into my chamber and vehemently tried me to evict from the suit premises. Again I objected their approach by showing the courts order and eventually they did not give any respect to the courts order there after they started abusing me with filthy language and even they while abusing me in my chamber and in presence of the other people the said Gobinda Das and Manju Das along with their son in law and daughter where they repeatedly uttered "Chotoloker Baccha, Tor Jat er Thik Nai, Chamar Kothakar, Akhonni Bero amar Dokan Thake nahole Gaye thu tu dea Jutor Mala Porea Ber Kore debo. Amra Boishnob age Janle esob Nichu Jater lok der Vara detam nah." Further they even shouted in public that no one in the locality shall accept me as tenant as I am from Scheduled Cast

Community and further the bebsaye samity also accepted the same by Mr.Kundu representing Ashighar Bebsaye Samiti.

Eventually after such act of insult and abusive approach by the said persons I am mentally traumatized and went through proper medications and thereafter after alling from such mental agony I came before this concerned authority to lodged this FIR.

Therefore this is my humble request before the concerned authority, kindly take necessary action against the Mr Kundu of Ashighar Bebsaye Samity, Gobinda Das, Manju Das along with their son in law and daughter against their illegal act of abusing me in public of being a member of Scheduled Cast Community further trying to evict me forcefully along with other hooligans where there is a specific order of the Ld. Civil Court protecting me from being evicted from my tenanted premises.




