In producing herewith four arrested accused persons namely (1) Tasiruddin Sk-25yrs s/Lt Mustak Sk of Mohammadpur, near Maszid, PS Kaliachak Dist Malda (not verified) (2) Vinoy Kumar-22yrs s/o Munni Bhagat, Mathura, near Budiya Maiya Mandir PS Bidupur Dist Baishali Bihar (not verified) (3) Saidul Sk-48yrs s/o Lt Ruddin Sk of Kismatpur near Jal Tanki PO-Shrirampur PS Kaliachak Dist Malda (not verified) and (4) Ajit Roy-24yrs s/o Lt Suresh Roy of Indra colony, Near BBD statue ward no-02 PS Kotwali Dist Jalpaiguri (not verified) along with the following seized articles under seizure as per seizure list:

- (1) 03 packets of Sodium carbonate -SQ, S0159 each packet containing 05 Kgs. One black colour backpack One Vivo mobile phone vide IMEI No-862897055672451 & 862897055672444 from the exclusive possession of Vinoy Kumar.
- (2) 300 grams of suspected to be Brown sugar & Cash Rs-5200/ with one Samsung keypad mobile phone vide IMEI No-352358704512512 from the exclusive possession of Saidul Sk. (Recovered from his vest)
- (3) 320 grams of suspected to be Brown Sugar & one redme mobile phone having IMEI No-863393042524533 & 863393042524541 with sim no-7076063146 from the exclusive possession of Tasiruddin Sk. (Recovered from his vest)
- (4) (i) 200 grams of suspected to be Brown sugar (ii) 976 grams of black colour sealed bottle contained with suspected liquid (iii) 976 grams of black colour sealed bottle contained with suspected liquid (iv) 1835 grams loaded in two plastic bottle contained with unknown liquid (v) One Oppo mobile phone having IMEI No-861188094262864 with sim no-909105756403 9vi) one packet of Sodium carbonate -SQ, S0159 each packet containing 05 Kgs from the exclusive possession of Ajit Roy all the articles kept in a backpack.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 20.12.25 at about 22.25 hrs, received a reliable source input that four persons was coming towards Salugara from Jalpaiguri side through Eastern bypass and NH-10 with huge quantity of brown sugar with raw materials of brown sugar for delivering the same to their designed customers at Hill area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 1074 dated 20.12.25 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 22.35hrs myself along with ASI Dipak Karmakar, ASI Dhurbo Mishra, ASI Khagen Barman, Const/374 Debraj Biswas, C/1431 Dilip Barman and C/783 Santious Minj all are Bhaktinagar PS with investigation kit left for Salugara side by govt vehicle to

verify the veracity of the information also informed PS night Van officer SI Sahajahan Ali (K-37) with force to come at the spot immediately. This refers to Bhaktinagar PS GDE no. 1075 dated 20.12.25 and M.C.C No- 6187/2025 Dated 20.12.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 22.55hrs we reached at NH-10 near Radio center, ward no-42 under Bhaktinagar PS and meanwhile called two independent witnesses namely; (1) Ajay Roy-24yrs (Ph-6294540165) s/o Debesh Roy of Sarbapally, ward no-42, PS-Bhaktinagar Dist- Jalpaiguri and (2) Bijay Roy-24yrs (Ph-7479184406) s/o Rabi Roy of Shanti colony, Uttar Ektiasal PS Bhaktinagar Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being accompanied by source and the witnesses our whole police party was waiting at NH-10 near Radio center, ward no-42. After some time we detained four persons at NH-10 near Radio center. We disclosed our identity and the information in hand and stated them that they will be searched in persons for the purpose. At this, they disclosed their name and address as noted above and also found they are carrying some bags on their possession. On being asked they admitted that they have illegally possessed brown sugar and raw materials of brown sugar in their possession for selling the same to their designed customers at Hill side as per requirement for their wrongful gain.

I then gave an option in writing whether they will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return they have given in written reply that they are willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station through my personal mobile phone (No-9733284548) to come to NH-10, near Radio center ward no-42 requested him to presence during search and seizure of the suspected to be brown sugar with raw materials of brown sugar. Accordingly at 23.45 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities and recovered the above noted articles from the possession of above noted accused persons. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazette Police Officer the detained persons failed to produce any valid document in support of possessing of the brown sugar and raw materials of brown sugar.

Thereafter, I recovered (1) 03 packets of Sodium carbonate -SQ, S0159 each packet containing 05 Kgs. One black colour backpack One Vivo mobile phone vide IMEI No-862897055672451 & 862897055672444 from the exclusive possession of Vinoy Kumar.

(2) 300 grams of suspected to be Brown sugar & Cash Rs-5200/ with one Samsung keypad mobile phone vide IMEI No-352358704512512 from the exclusive possession of Saidul Sk. (Recovered from his vest)

(3) 320 grams of suspected to be Brown Sugar & one redme mobile phone having IMEI No-863393042524533 & 863393042524541 with sim no-7076063146 from the exclusive possession of Tasiruddin Sk. (Recovered from his vest)

(4) (i) 200 grams of suspected to be Brown sugar (ii) 976 grams of black colour sealed bottle contained with suspected liquid (iii) 976 grams of black colour sealed bottle contained with suspected liquid (iv) 1835 grams loaded in two plastic bottle contained with unknown liquid (v) One Oppo mobile phone having IMEI No-861188094262864 with sim no-909105756403 (vi) one packet of Sodium carbonate -SQ, S0159 each packet containing 05 Kgs from the exclusive possession of Ajit Roy all the articles kept in a backpack.

Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and accused person. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between on 21.12.25 at 00.05hrs to 01.45 hrs.

Being further asked, the apprehend persons namely (1) Tasiruddin Sk-25yrs s/Lt Musak S of Mohammadpur, near Maszid, PS Kaliachak Dist Malda (not verified) (2) Vinoy Kumar-22yrs s/o Munni Bhagat, Mathura, near Budiya Maiya Mandir PS Bidupur Dist Baishali Bihar (not verified) (3) Saidul Sk-48yrs s/o Lt Ruddin Sk of Kismatpur near Jal Tanki PO-Shrirampur PS Kaliachak Dist Malda (not verified) and (4) Ajit Roy-24yrs s/o Lt Suresh Roy of Indra colony, Near BBD statue ward no-02 PS Kotwali Dist Jalpaiguri (not verified) admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that they procured the Brown sugar and raw materials of brown sugar clandestinely from Malda for the purpose of selling the same in high rate to their designed customer at Hill side for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of Brown sugar and raw materials of brown sugar for last few months. The raw materials will be use to prepared Brown Sugar by their customers who will be coming from Hill side.

Then, I arrested the above noted accused person namely (1) Tasiruddin Sk-25yrs s/Lt Musak S of Mohammadpur, near Maszid, PS Kaliachak Dist Malda (not verified) (2) Vinoy Kumar-22yrs s/o Munni Bhagat, Mathura, near Budiya Maiya Mandir PS Bidupur Dist Baishali Bihar (not verified) (3) Saidul Sk-48yrs s/o Lt Ruddin Sk of Kismatpur near Jal Tanki PO-Shrirampur PS Kaliachak Dist Malda (not verified) and (4) Ajit Roy-24yrs s/o Lt Suresh Roy of Indra colony, Near BBD statue ward no-02 PS Kotwali Dist Jalpaiguri (not verified) after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Tasiruddin Sk-25yrs s/Lt Musak S of Mohammadpur, near Maszid, PS Kaliachak Dist Malda (not verified) (2) Vinoy Kumar-22yrs s/o Munni Bhagat, Mathura, near Budiya Maiya Mandir PS Bidupur Dist Baishali Bihar (not verified) (3) Saidul Sk-48yrs s/o Lt Ruddin Sk of Kismatpur near Jal Tanki PO-Shrirampur PS Kaliachak Dist Malda (not
