Sir,

I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Krishna Agarwal (Present user, Ph No-8016682843), S/O- Niladhar Agarwal, Sonar Tari apartment ground floor, Block-A, Netaji Sarani, Hyderpara, Ward no-39, PS-Bhaktinagar, Dist-Jalpaiguri, Pin-734006 for having committed offence as stated here under.

On 22.12.2025 at about 12.29 PM. acting on a source information I, along with 1) Sri Bijay Lakra, S.E., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, 3) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Subrata Dey and inspected service installation, metering installation of Consumer ID **412253304** in the name of Subrata Dey. During inspection it was found that Krishna Agarwal (Present user) is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 03.07.2025 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 7202.00 (Rupees seven thousand two hundred and two only) including the LPSC of Rs. 390.00 (Rupees three hundred ninety only) till the date of 22.12.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Bentec Electricals & Elec Ltd, serial no.- **IPB257276** installed against Con Id. **412253304**, seized by preparing a formal seizure list duly signed by witnesses.

As Krishna Agarwal (Present user) have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. 
