Sub: Written Complaint

Sir,

I, Bhajan Sarkar, Son of Late Nagendra Sarkar resident of Uttar Shantinagar, PS- Bhaktinagar, Dist.—Jalpaiguri beg to inform you that just opposite of my house, resides one Animesh Sarkar along with his wife Mampi Sarkar, elder daughter Anamika Sarkar and a younger son. The said Animesh Sarkar has taken personal loan from me on various occasion on good faith and over the trust of being neighbours but not a single penny was returned or paid back by him and whenever, I demanded money, the said Animesh Sarkar used to avoid me and placed his wife Mampi Sarkar to face the situation.

The said Mampi Sarkar being a clever and witty woman, under the instructions of her husband Animesh Sarkar, tried to make me fall for a trap in the name of relationship. The said Mampi Sarkar used to instigate and influence me; and me out of my innocence and kind hearted nature failed to understand the witty nature and malic intentions of Mampi Sarkar and consequently, had fallen into their trap resulting to the development of a relationship in between me and the said Mampi Sarkar.

During this period, the said Mampi Sarkar using her utter intelligence kept dragging me into her trap and even took few private pictures of mine. Since then, whenever I demanded to return my money, the said Mampi Sarkar and her husband Animesh Sarkar kept on threatening me to derogate me publicly by destroying my reputation in front of the society, my minor daughters and other family members. By then, I was totally in a helpless situation and was not even able to share my thoughts/feelings regarding this with anyone; consequently, I had developed depression, agony and various health related issues.

At night of 08/12/25 at about 09:30 P.M., while returning from work, and being in urgent need of money, I met with the said Animesh Sarkar and demanded him to return my entire sum of Rs. 1,30,000/- and he assured to return the money by morning.

Thereafter, in the morning of 09/12/25 at around 06:30 A.M. the said Mampi Sarkar, forcefully entered into my house, created nuisance by causing trouble and even threatened my wife Jharna Sarkar (since deceased) by stating that if she does not keep numb or if I demand to return my money again, the said Mampi Sarkar will reveal

everything about my relationship publicly thereby destroying my reputation publicly. Failing to tolerate such words, my wife under the pressure, instigation and influence of Mampi Sarkar suffered huge mental agony and was forced to intake a medicine solely used for plants i.e., *Nano urea*. Resulting which my wife became unconscious. Later, when my wife was taken to hospital, the attending doctor admitted her but unfortunately, due the severe effects of the said liquid, she succumbed to death on 11/12/25. And due to loss of my wife, I was totally shocked, surrounded by the clouds of melancholy, suffered severe depression and was not able to take any appropriate steps.

Seeing such a situation, my daughter Susmita Sarkar submitted a written complaint before you on 12/12/25 against the aforesaid Animesh Sarkar and Mampi Sarkar narrating the entire incident.

Hence, I humbly request you to take appropriate legal actions against the said Mampi Sarkar and Animesh Sarkar who influenced, instigated and forced resulting the death of my wife. They are directly involved to cause death of my wife.
