Sir,

In producing herewith the female accused person named Shulekha Begam, aged 46 years, w/o- Hussain Mahammad, resident of Hathkhola, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 8768 5313 3291) under custody along with following seized articles under proper seizure list:

1. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- A.
2. Five (05) ltrs of Chullu in one red colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- B.
3. Five (05) ltrs of Chullu in one red colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- C.
4. Thirteen (13) bottles of "Himalayan Fata Fati 70° UP India Made Liquor", each contains 300 ml @ Rs. 50/-, out of which 01 bottle is taken out as sample and marked as Exhibit-D.

I, ASI Amit Lama of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested female accused person named Shulekha Begam, aged 46 years, w/o- Hussain Mahammad, resident of Hathkhola, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling to the effect that on 12.12.2025 at 14:30 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect named Shulekha Begam located at Hathkhola, Upper Bagdogra under Bagdogra PS and the same has been selling illegally from that house cum shop for her wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, ASI Munna Ahmed, LCV/1025 Anila Singha, LCV/211 Jayanti Barman, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Hathkhola, Upper Bagdogra under Bagdogra PS, SPC by Govt. vehicle No. WB61A/0137 to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as of the escape of the offender. The matter is diarised in GD vide Bagdogra PS GDE No. 538 dated 12.12.2025. At around 14:40 hrs we reached at Hathkhola, Upper Bagdogra and had been waited there for source indication. Thenafter, at around 14:45 hrs the source indicated us and being indication & identification by source we held raid at the house cum shop of the suspect Shulekha Begam and I managed to apprehend her with the help of accompanying lady Police personnel and interrogated her. On interrogation, she revealed her identity as Shulekha Begam, aged 46 years, w/o- Hussain Mahammad, resident of Hathkhola, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling and introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We searched for the independent witnesses to be present there as witness during the process of search, seizure, if any. Two independent witnesses named Amal Barman, aged 42 years, s/o- Late Jiten Barman, resident of Hathkhola, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9647502267) and Laxman Routh, aged 35 years, s/o- Late Nandu Routh, resident of Ho-Chi-Min Nagar, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7384694330) were present there to witness the process of search and seizure, if any. Then, we searched the house cum shop in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, the detainee failed to produce any valid document/license for stocking, possessing & selling that liquor from her house cum shop. She confessed that she has been stocking, possessing & selling liquor illegally from her house cum shop since long time for her wrongful gain. Her involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) from her possession under proper seizure list and at last, I arrested the involved accused Shulekha Begam
