In producing herewith the 01 (one) arrested lady accused person namely Nazim Khatun (26 yrs approx), W/O- Md. Nural of Biswas Colony near Rail Gate, PO+PS- Matigara, Dist- Darjeeling (not verified) along with the following seized article under proper seizure list :-

- (i) One transparent plastic packet containing suspected to be brown sugar weighing 103 (one hundred and three) grams and marked as 'Exhibit-A'
- (ii) Cash amounting to Rs- 5,30,400/- (Five lakh thirty thousand and four hundred) containing in various denomination of Indian Currency Notes.

I, PSI Avijit Banik, of Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that on 23.12.2025 at about 15:30 hrs, received a specific information provided by a credible source that 01 (one) lady is selling huge quantity of illegal Brown Sugar at her house at Biswas Colony near Rail Gate under Matigara PS.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide Matigara PS GDE No. 1248, Dated- 23.12.2025 and I intimated the information to Shri Arindam Bhattacharjee, IC Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 15:45 hrs myself, along with a team of Matigara PS, SPC consisting of ASI Bikash Roy, ASI Dipak Kr. Chhetri, ASI Chandra Prakash Athikari, C/219 Sonam Chakraborty, C/865 Sajal Roy, LC/1286 Anisha Chhetri all are of Matigara PS, SPC took departure vide C.C. No- 2798/25 dated 23.12.2025 from Matigara PS, SPC in Biswas Colony near Rail gate under Matigara PS with investigation kit containing envelope, white paper, sealing wax, gum, seal, digital weighing machine and other investigation kits by a Govt. vehicle to work out the information and the same was diarized vide Matigara PS GDE No. 1249, dated- 23.12.2025.

At the same time I also informed the videographer namely Somnath Chatterjee, S/O- Sushil Chatterjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Biswas Colony near Bypass more, under Matigara PS, SPC to prepare the video of whole process of search and seizure if any. On 23.12.2025 at about 16:05 hrs, we reached at Biswas Colony near Rail Gate under Matigara PS and I met with my source and he briefed me about the detail information and indicated the house of the suspected lady. Before that I looked up for public witnesses to the entire process of search and seizure. I found so many people but two of them gave their willingness to act as independent witnesses. The particulars of the witnesses are as follows 1) Md. Jhar Ali (47 yrs), S/O- Lt. Wajid Ali of Biswas Colony, PO+PS- Matigara, Dist- Darjeeling and 2) Md. Rasmudding (61 yrs), S/O- Lt. Md. Jamirudding of Biswas Colony, PO+ PS- Matigara, Dist- Darjeeling and I briefed them about the information we had and requested them to stand as witness, who agreed to be stand as witness during the process of search and seizure and other process thereafter. Accordingly we proceeding towards the house of the suspected lady.

In the meanwhile, IC, Matigara PS sent a message to SDO, Siliguri to depune an Executive Magistrate during search & seizure of NDPS substances as per norms vide ORG No. 4106/23, Dated- 23.12.2025. But after a telephonic conversation, it came to know that due to engage in other duty and short notice, there are no Executive Magistrate available to perform the duty.

In the above circumstances and the gravity of the information, if any delay occurred, the suspected lady may escape. Hence, as per order of superior, I/C, Matigara PS left PS for the place of occurrence to supervise the search & seizure if any.

At about 16:30 hrs, we had been at the house of the suspected lady and managed to apprehend her. I introduced myself and the raid team members as Police officers. I apprised her about the information in hand and started to examine her thoroughly. On interrogation she disclosed her name and address as mentioned above. On interrogation the detained lady admitted that she is possessing a huge quantity suspected to be Brown Sugar at her house and selling the same from her house.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained to the above noted detained lady that she has the legal right to tender the searching process in front of an Executive Magistrate or a Gazetted Officer and the same was given to her in writing. In reply she wanted to be searched before any officer and she does not want to search the police team. At about 16:40 hrs Sri Arindam Bhattacharjee, I/C Matigara PS arrived at the spot as a Gazetted Officer along with Sri Sajid Iqbal, ACP West-II, SPC who acted as a supervising officer, where I briefed them the information in a nutshell. Also introduced the witnesses as noted above.

On further interrogation, the detained lady admitted in front of the Gazetted officer that she was in conscious possession of a huge quantity of Brown Sugar at her house and selling the same from her house.

Thereafter, in presence of the Gazetted officer, and the two independent witnesses lady constable searched the detained lady namely Nazira Khatoon after observing all formalities but nothing was recovered from her person except wearing apparels. Then the room of the detained lady as indicated by herself was searched and found one transparent plastic packet containing suspected to be brown sugar and Cash.

On interrogation, she stated that she brought the suspected to be brown sugar from Malda and selling these to her designated customer at Biswas Colony area under Matigara PS. Then, I asked her to produce the valid license/ documents for possessing the huge quantity of illegal narcotics contraband articles and the cash which was also recovered from her house but she failed to produce any legal papers. She also admitted that the cash was obtained by selling Brown Sugar.

After weighting the transparent plastic packet which was recovered from the house of the detained lady in her possession is weighted 103 grams and after counting the cash which was recovered from the house of the suspected lady it was amounting INR 5,30,400/- (Five lakh thirty thousand and four hundred) containing various denomination of Indian Currency notes. Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated by the NDPS Act, and the cash was obtained by selling illegal brown sugar. Accordingly, I had seized the above noted articles under proper seizure list duly prepared by me in presence of independent witnesses and Sri Arindam Bhattacharjee, I/C Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer and Sri Sajid Iqbal, ACP West-II, SPC who acted as a Supervising officer. I also took signatures of the witnesses, the lady accused and Gazetted officer and submitted my signature as seizing officer.

Thereafter, 103 (one hundred and three) grams suspected to be Brown Sugar have been properly marked and labeled as 'Exhibit-A'. Took signature of witnesses and the lady accused in the label in presence of the Gazetted officer.

I then arrested the above noted lady nocessed after informing her the ground of arrest for possession of contraband Narcotic drugs under the NDPS Act and issued an arrest memo to her accordingly, duly signed by the lady accused and witness and the lady constable.

The entire process of Search, seizure, Label, Seal and arrest were done in between 16:50 hrs to 17:40 hrs. The entire process of search, seizure, sealed and labeled was done under the supervision of Sri, Arindam Bhattacharjee, I/C Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer and Sri Sajid Iqbal, ACP West-II, SPC who acted as a supervising officer and videography of the search and seizure process was conducted through the camera of Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Golchel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling in compliance with the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange for its investigation against lady accused namely Nazira Khatoon (26 yrs approx), W/O- Md. Nural of Biswas Colony near Rail Gate, PO+PS- Matigara, Dist- Darjeeling (not verified) and others involved in this racket.
