I respectfully submit this application to inform you about a road traffic accident that occurred on 20th December 2025, between 7:00 PM and 7:20 PM, at TCP More, which falls under the jurisdiction of Matigara Police Station.

At the said date and time, I was riding my vehicle bearing registration number AR-01-C-7479, along with my daughter. While proceeding normally, a vehicle bearing registration number WB-73-L-5897 came at high speed and in a rash and negligent manner and hit my vehicle. After causing the accident, the said vehicle fled from the spot without providing any assistance, thereby committing a hit and run offence.

As a result of the accident, we suffered injuries and mental trauma, and my vehicle was also damaged. The incident has caused us significant physical, mental, and financial hardship.


