Most Humbly, I Sri Bharat Roy, Son of Sri Rajan Roy, Resident of South Shanti Nagar, Near Polytechnic College, Under Dabgram ii Gram Panchayat, P.O Dabgram, P.S New Jalpaiguri, Dist-Jalpaiguri, do here by write this complaint letter before you to stating that my younger toto Rickshaw in Siliguri for living his yrs, by profession Toto Driver, who drive toto Rickshaw in Siliguri for living his life, further I state that like every day he was standing Hongkong market More. Hill Cart Road, Opposite Punjab national Bank, Ward no-11 of SMC, Under Siliguri Police Station, Dist-Darjeeling and today on dated-23/12/2025 at Night within 8:00 to 9:00 he was stand near by the market and a passenger was sitting in his Toto E-Rickshaw for going to Junction Station but suddenly a person namely **Bapi Sutradhar@ Puchki**, Son of Manoranjan sutradharm, Resident of Kumar Toli, Near Lal Mohan Ghat, Under ward no-4 of SMC, P.S-Siliguri, reached near his Toto and suddenly he started the taking out the passenger forcefully from E-Rickshaw, he trying to take his bag forcefully having intention with snatching but when my brother stopped him and try to said him that he is a tourist then he suddenly anger upon my brother and started saying filthy languages as well as threatened my brother to kill him. In this situation the Passenger get very scared and my brother suggest the passenger to take a private cab for going safely at junction station but when the passenger was went from the place then the said person was took out a **sharp weapon Khukri** from his Toto E-Rickshaw and attacked upon my brother from the back side but suddenly my brother felt down on the road and he started beaten my brother badly by his hand with **wearing of iron punch** which is sharp and hit upon his face and head by Khukri and resulting in his face and ear is cut by this weapon and from the iron punch he get grievous injury in his face and head when my brother got serious and unconscious then he snatched my brother's neck silver chain as well as his money and saw this and shout this incident the local driver are ran away to save my brother and this person ran away from the place, when the driver take my brother at district hospital in that time blood were swelling from his ear and head and his face and eye was
