I Nupur Saha, Wife of Umesh Sahani, Resident of Kutijote, Naxalbari,
Near Bidroi Club, P.S. Naxalbari, Dist:- Darjeeling, begs to state as follows:-

1. That today i.e. 24/12/2025 at around 10:00 AM, I along with my husband came to Siliguri from my house to stay in Siliguri for a day and on the very next day we had a plan to go Hills for a vacation.
2. That after checking in at North Point Hotel my husband received a call from his one friend namely Sudip and he asked where my husband was to which he said at Siliguri in hotel north point hearing this he immediately after few moment came below the hotel along with few other people and took my husband and when it became too long for my husband to return I became worried and started searching for my husband and after an hour I received a call from one mobile number 70013-99025 and it happened to be my husband on the other side and my husband seems to be sounding very scared and while crying in pain he said to bring some mony as all his money has been snatchd by his friend and his gang and all money has also been taken by then and they have been beating my husband with fist and blows and kicka and also with lathi.
3. That my husband also stated over the fone that he was kidnapped in a brode day light and take away in a deserted place back side of TB Hospital Sevoke Road, Siliguri and beaten mercilessly and was extorted money by a group of people along with his friend.
4. That finding no other way and alternative I came before the OC panitanki TOP for the rescue of my husband.
