I Puja Kumari (Mobile No.7384954879) daughter of Sri Ashok Sah,  
resident of Durga Nagar Colony, Gurung Basti, Ward No.III of S.M.C., P.O. &  
P.S. Pradhan Nagar, Dist. Darjeeling, Pin-734003 beg to report you the  
following facts:-

1. That Sri Suraj Roy son of Late Sarwan Roy of Toribari, P.S. Bhaktinagar,  
Dist. Jalpaiguri is my legally married husband. My marriage was  
solemnised with him on 20/03/2021 at Kali Temple at Bartala, P.O.  
Champasari, P.S. Pradhan Nagar, Dist. Darjeeling according to Hindu  
Law, rights and customs in presence of my husband's elder sister, my  
parents, friends and well wishers.

At the time of marriage my Parents gave cash Rs. 2,00,000/- (Rupees  
Two Lac), different Gold Ornaments total weigh 3 voris, different Silver  
ornaments total weigh 10 vories, different furnitures including wooded  
double bed cot, dressing table, dining table with chairs etc total worth  
Rs.1,50,000/- (Rupees One Lac fifty thousand) and different utensils and  
cloths total worth Rs.30,000/- (Rupees thirty thousand) to my husband as  
per his demand and the demand of his parent.

They were not satisfied with the aforesaid dowry cash amount and  
articles, so they started to demand more cash and articles and gold  
ornaments from us soon after my marriage. I could not full fill their  
demand.

After marriage I started to live/reside my husband together as  
husband and wife at the house of my husband's elder sister namely Smt.  
Manju Das wife of Dulal Das at Zamai Bazar, Near- Sani Mandir, P.O.  
Champasari, P.S. Pradhan Nagar, Dist. Darjeeling.

So, my husband, and my Nanad (Sisters –in – Law) Smt. Manju Das wife of Dulal Das started to tortured upon me both physically and mentally in different ways.

After residing 18 (Eighteen) months I left the house of my husband's elder sister house at Zamai Bazar, Near- Sani Mandir, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and started to live/reside with my husband at my in laws house at Toribari, Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin- 734008.

2. That my husband, my mother-in-law Smt. Astami Roy and two brother in law namely Sri Ramesh Roy and Sri Suman Roy continued to tortured upon me both physically and mentally.
3. After residing 3 (Three) months at my in laws house at Toribari, Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, and I again started to live/reside with my husband at Durga Nagar Colony, Gurung Basti, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling at the house of Smt. Ramawati Devi as a tenant.
4. That on 12.10.2025 at about 1.00 P.M. to 1.30 P.M. my husband assaulted me continuously by fists and blows and by kicks and also by lathi. Thereafter he poured keorasin oil on my body and try to set fire upon me but any how I saved myself from his hands. His intention was to murder me by burning by fire in such way. After that I phoned to the Pradhan Nagar Police station in 100 dial and he flew away from the house at Durga Nagar Colony, Gurung Basti, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling. For such assaulted I sustained severe injuries on my persons and I was medically treated and admitted on 12.10.2025 at about 5.00 P.M. at Siliguri District Hospital and Discharge on 13.10.2025. Still I am seriously ill for such assault.

5. That again to-day on 17.12.2025 at about 3.20 P.M. again he assaulted me by fists and blows and by kicks. Then I shouted and he flew away from the house at Durga Nagar Colony, Gurung Basti, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling and the local people came to my house and save me from him.

I therefore request you to kindly take necessary steps against the aforesaid culprits i.e., against my husband and my aforesaid in- laws for the commission of the aforesaid offences upon me.
