Respected Sir,

I, **Shri Shankar Gupta**, son of Late Bharat Prasad Gupta, resident of Ganga Nagar, near Somnath Mahadev Mandir, Ward No. 5 under Siliguri Municipal Corporation, P.O & P.S Siliguri, District Darjeeling, do hereby Write this complaint before you Stating that on 24-12-2025, at around 11:30 PM, two individuals **Vivek Singh @ Prashant Singh**, son of **Sri Guddu Singh**, resident of Ganga Nagar and **Vikash Jha @Chumma** along with 4 to 5 persons forcefully entered my godown Situated at Ganga Nagar, Near Panchadev mandir, premises belonging to my nephew, Shri Akash Gupta, where staff members reside, and they started demanding money as Gunda Tax around Rs.50,000/- (Fifty Thousand) and said them that you all staff are from outside and doing work in our locality so you have to pay us Gunda tax either they did not allow them to reside them the locality as well do not running their business when the staff members called my nephew and refuse to pay them then above-named individuals are Stared assaulting them physically by took out weapon (Iron Rod) from their vehicle, and when my nephew reached at godown then the two persons namely individuals **Vivek Singh @ Prashant Singh**, son of **Sri Guddu Singh**, and **Vikash Jha @Chumma** took out sharp weapon Khukri and keep the sharp weapon over his neck and snatched Rs.8300/- (Eight thousand three hundred) from his pocket and further they threatened him that if he did not pay them Rs.50,000/- within 2 days neither they burn his shop and they said and accept that they try to burn the said shop on dated -21/12/2025 around 5:00 am and the complaint was lodged by me on the same day and, after taking money they escape from the place when i called them then the both persons are threatened me to kill and on the next day on dated 25/12/2025 at morning 4:00 AM they try to burn the shop by spreading fuel but unfortunately they try to burn my neighbour shop again the local public who out from the house for morning walk who saw the all incident and inform me then we reached the place but we control it, I believe that these are the persons who attempted this illegal activity at Morning I further submit that the injured staff members were medically examined at Siliguri District Hospital, and I am enclosing the relevant medical documents and injury reports in support of this complaint.
