Subject: FIR for Criminal Breach of Trust by Carrier regarding shortage of goods in transit.

Respected Sir/Madam,

I, Om Prakash Singh S/O Kailashnath Singh (AADHAR NO. 411827489407) Authorized Signatory of Shree Azad Carrying Pvt. Ltd. having our office at Siliguri Mittal compound, Sevoke Road Siliguri (W.B.) 734001

1. Entrustment of Goods: Our company was booked by the consignor, Alkem laboratories Ltd to transport a shipment of medicine from Ashighar More Phapri, P.S- Bhaktinagar to Muzaffarpur under our Lorry ReceiptNo..29769. Alkem Invoice No. 7113045559, 5560, 5561.
2. Hiring of Third-Party Vendor: For the execution of this transit, we hired a vehicle through M/s Quick Digital Technologies Pvt. Ltd located Bilaspur, Bhora Kalan, NH-8, Delhi Jaipur Highway, Near Park Inn Hotel Gurugram (HR) Vehicle taken from his Kolkata branch, The goods were loaded onto Vehicle No. BR01GM1290, driven by Mithun Kumar S/Jainandan RayLicense NoBR3120210011189. Mob No. 7061903486.
3. Handover in Good Condition: On 19.12.2025, the full quantity of 1151 c/box was loaded at Siliguri in sound condition and handed over to the said driver/vendor.
4. Discovery of Shortage: The vehicle reached the destination in Muzaffarpur on 22.12.2025. Upon arrival, the consignee and there was a shortage of 53 C/box. The value of the missing material is Rs 1731480/-
5. Allegation: Since the goods were in the exclusive custody and control of the third-party vendor and their driver from Siliguri to Muzaffarpur, and they have failed to deliver the goods in full as entrusted, we suspect a Criminal Breach of Trust and/or Theft committed by the driver and the vendor.

I request you to:

* Register an FIR against the Driverby Mithun Kumar S/ Jainandan Ray License No BR3120210011189. Mob No. 7061903486., and the Vendor M/s Quick Digital Technologies Pvt. Ltd.

- * Investigate the transit route to recover the missing material.
- * Provide us with a certified copy of the FIR for insurance purposes.
