



- 2) That the Complainant is the absolute and exclusive owner of a two and partly three-storied residential building standing on land measuring 4 Kathas, situated at Mouza-Dabgram, Pargana-Baikunthapur, B.L.&L.R.O-Rajganj, P.S.-Bhaktinagar, A.D.S.R. Office - Rajganj, Dist. Jalpaiguri, appertaining to J.L. No. 2, Ward No.43, Sheet No.6, Khatian No.429, Plot No.64, Holding No.8/18211, located at Rajendra Road, Prakash Nagar, Siliguri.
- 3) That Accused Person No.1 is the maternal Aunt (Mousi) of the Complainant and the Accused Person No.2 is the son of the Accused Person No.1.
- 4) That in the month of July 2025, Accused Person No.1 requested temporary permission to reside in the complainant's building with her family. Relying on such request, the Complainant allowed them to stay on the second floor of the complainant's building during the month of August-September 2025.
- 5) That in the month of October 2025, the accused persons voluntarily vacated the premises and shifted to their newly purchased house at Samar Nagar, Siliguri.
- 6) That on 22.11.2025, the accused persons forcibly re-entered in the premises without permission, trespassed into the complainant's building and started residing there illegally.
- 7) That on 24.11.2025, Complainant rushed to Siliguri, revoked the earlier permission and requested them to quit and vacate the premises. The accused persons refused and threatened the complainant with dire consequences, including threats to kill her if she attempted to enter her own house.
- 8) That on 25.11.2025, the petitioner lodged a written complaint at Bhaktinagar Police Station narrating the illegal trespass, criminal intimidation and threat to life.


However, no effective police action has been taken till date.


Subsequently, on 29.11.2025, complainant went to Siliguri Police Commissionerate and lodged a written complaint against the accused persons. In spite of that no positive steps has not been taken yet.

- 9) That the inaction of the police has emboldened the accused persons, who continue to occupy the complainant's property unlawfully and pose a serious threat to her life and peaceful enjoyment of her property.
- 10) That the continuous threats, coercive tactics, and attempts to interfere with complainant's peaceful possession are causing the complainant and his family tremendous mental agony, financial loss, and physical hardship.
- 11) That the Complainant found no other alternative but to come before Your Honour and hence this application is filed for proper action.

Under the above circumstances it is prayed that Your Honour would be graciously pleased to send this complaint to the Inspector-in-Charge, Bhaktinagar Police Station, after treating this complaint as F.I.R. directing the Bhaktinagar Police Station to investigate the matter properly for the ends of justice.

And for this act of kindness your Complainant as in duty bound shall ever pray.
