Sir,

In producing herewith one arrested person namely Biswanath Mandal-54yrs s/o Lt Gobinda Chandra Mandal of Faridkati, PO East Bishnupur PS Ghaighata, Dist North 24 Pargana under proper arrest u/s 35 of BNSS.

I beg to report that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee now attached at Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested person to the effect that on 28.12.25 while myself along with ASI Khagen Barman & Force performing PS mobile van duty, at about 01.35 hrs received an information from Special operation Group, SPC that when they had been to "HALF -FULL Restaurant-cum Bar " at Planet Mall, 3<sup>rd</sup> Floor, Sevoke road to routine visit of closing the Bar in time at 01.00 hrs as per order of The Superintendent of Excise, Jalpaiguri vide order no-2552/E Dated 27.12.25 and they are found that the Bar was running up to 01.30 hrs after violation of permission by Excise department, Govt of West Bengal, so SOG team requested me to assist them at "HALF -FULL Restaurant-cum Bar " at Planet Mall, 3<sup>rd</sup> Floor, Sevoke road immediately to control the situation.

After receiving the information as per Kind direction of I/C of PS Myself along with other officers and force left for HALF -FULL Restaurant-cum Bar " at Planet Mall, 3<sup>rd</sup> Floor, Sevoke road. After reaching the Planet Mall found that SI Binod Jha and force all are SOG, SPC were present there. As per their statement checked the CC Camera footage found that the allegation is correct. The Bar was running up to 01.30hrs on 28.12.25 after violating the Govt order under the leadership of Bar Manager Biswanath Mandal.. I tried to serve notice u/s 35(3) BNSS but he refused to accept the notice and showed unwillingness to close the bar. Finding no other alternative, I arrested the above noted person to enforce the order passed by Govt. authorities after issuing arrest memo and ground of arrest. I also video graphed the scene with my mobile camera.

I therefore pray that a specific case may kindly be initiated against the accused persons namely Biswanath Mandal-54yrs s/o Lt Gobinda Chandra Mandal of Faridkati, PO East Bishnupur PS Ghaighata, Dist North 24 Pargana and also management of the "HALF -FULL Restaurant-cum Bar " under proper sections of law.
