Respected Sir,

This is to let you know that the undersigned went to visit Bhujibani HWC today at around 10:30 am and when I came down from my vehicle and was standing in front of the HWC. Suddenly one Susanta Mondal and 3 others came in two bikes and starting shouting at me. They started to do my videography and accused me. They forcibly stopped the work which was going on. Suddenly one of the accompanions of Susanta Mondal who was wearing a pink sweater started abusing me in slang languages. Moreover they started pushing me and harassed me without any reason. Ultimately I was forced to call you and then police came and the villagers eventually rescued me.

In addition to this Susanta Mondal forcibly entered the HWC in two occasions previously when my only female CHO was present in the HWC and without talking any permission from the CHO, he went upstairs and started making videos. My female staffs are already panicked and they also in mental agony.

Now, I am in mental agony and physically harassed. In this condition, I need your full support and assistance. The undersigned also request you to take strict action in this regard, so that no such future incidents may occur.
