I **Shri Shankar Gupta**, son of Late Bharat Prasad Gupta, resident of Ganga Nagar, near Somnath Mahadev Mandir, Ward No. 5 under Siliguri Municipal Corporation, P.O & P.S Siliguri, District Darjeeling, do hereby Write this complaint before you Stating that I and my brother is the owner of a Tin Structure shop, (Pan Shop) situated at Santoshi Nagar More, Behind Burdwan Inn Hotel, Under Ward no-5 of SMC, P.S-Siliguri, That Last night on dated 26-12-2025, at around 10:30 PM I locked my shop and go to sleep inside the shop, the next day dated-27/12/2025 around 5:00 am at morning some anti-social elements are came near my shop and by spreading petrol on my shop set fire by intention to kill me , they start burn my shop and the fire started burning and my shop caught fire in that time some local people are passing near my shop for morning walk they saw the all incident and started shouting loudly and the persons who are doing this illegal work they ran away and the local persons throwing sand and water they stop the fire and due to fire my counter was burned as well as electricity board started fire on that time the local shouted loudly then I wake up due to heavy smoke I got suffocation in the shop and that time I has breath problem but help of local people I came out from my shop and the accident was controlled by them. Further I state that last few day ago on dated-21/12/2025 & 25/12/2025 the both day these same persons do the same illegal work in my shop and due to this for safety my shop I go to sleep at my shop from the day of 25<sup>th</sup> December.

That on dated 25/12/2025 I was lodged complaint before to you(Refrence Siliguri Police case no-837/2025) in same act against persons namely 1. **Vivek Singh@ Prashant Singh son of Sri Guddu Singh and Vikash Jha @Chumma) son of Bhogendra Jha 3. Aman Singh 2 Aman Pandit @ Aman Singh Son of Sri Manoj Pnadit** along with 4 to 5 persons who physically assaulted my nephew and extorted money from my nephew they also threatened me at that time, that if we did not pay them as Gunda Tax around Rs.50,000/- (Fifty Thousand) they did not allow us to do business at the said locality they closed our shop and kill me as well as my family members also and today again they did the same

act in my shop with intention to kill me because they know very well that I was in the shop for sleeping and I believe that today this incident was doing by the same persons and some local people are again saw them . So I further request before you to kindly take necessary strict action against the all persons for burn my shop again and again to kill me by set fire and damaged my shop as well as for extortion money from my nephew and me.
