In producing herewith three accused persons namely 1) Subhamoy Roy (M/35) S/O- Lt. Subhash Ch. Roy of Milanpara Raiganj, Uttar Dinajpur A/P- Hakimpara, near Vivekananda School, P.S- Siliguri, Dist- Darjeeling. 2) Ashok Saha (M/31) S/O- Lt. Amal Saha of Bidyachakra Colony, W/No.44, P.S- Bhaktinagar, Dist- Jalpaiguri 3) Jayanta Saha (M/27) S/O- Jaydev Saha of Bidyachakra Colony, W/No.44, P.S - BhaktinagarDist- Jalpaiguri under arrest along with connected papers.

I, SI Prakash Chandra Sarkar S/O. Kartik Sarkar of Panitanki TOP under Siliguri PS, SPC lodged this written complaint against three arrested accused persons namely 1) Subhamoy Roy (M/35) S/O- Lt. Subhash Ch. Roy of Milanpara Raiganj, Uttar Dinajpur A/P- Hakimpara, near Vivekananda School, P.S- Siliguri, Dist- Darjeeling. 2) Ashok Saha (M/31) S/O- Lt. Amal Saha of Bidyachakra Colony, W/No.44, P.S- Bhaktinagar, Dist- Jalpaiguri 3) Jayanta Saha (M/27) S/O- Jaydev Saha of Bidyachakra Colony, W/No.44, P.S - BhaktinagarDist- Jalpaiguri and others to the effect that Yesterday i.e. on 28.12.25 at 23.25 hrs duty officer ASI Supriya Mondal received an information that a brawl is going on near Makhan Bhog, Sevoke Road, Siliguri accordingly duty officer informed O.C Panitanki TOP and as per his direction I SI. Prakash Ch Sarkar along with ASI Mantu Dey, k-28 Van officer along with other officers and force rushed to the spot at 23.35 and found that 6-7 persons were creating Halla and nuisance also they are carrying Lathi, hockey stick in their hands and they are engaged in hot altercation with each other also uses slang languages. Seeing the situation I along with other officer and force intervened and asked them to stop but hearing my words some of them agreed but some continuing their act by violating the direction of me i.e. an on duty Police officer and they also pay no heed to my words. Then I along with other officer going to stop them but then the said accused persons started threatening us and I then tried to make them understand that in such night hours Public in general would be panic by their act and the peaceful situation of the area are being hampered. They pay no heed to my words and finding no other option I going to arrest them but they didn't cooperate and started assaulting myself and other Police personnel and also discharged us in performing our government duty. Finding no other alternative way three persons were apprehended and others fled away, also I arrested three persons by issuing arrest memo and maintaining other formalities and brought them to Siliguri P.S.


I therefore request you a specific case may kindly be started against the arrested accused person namely 1) Subhamoy Roy (M/35) S/O- Lt. Subhash Ch. Roy of Milanpara Raiganj, Uttar Dinajpur A/P- Hakimpara, near Vivekananda School, P.S- Siliguri, Dist- Darjeeling. 2) Ashok Saha (M/31) S/O- Lt. Amal Saha of Bidyachakra Colony, W/No.44, P.S- Bhaktinagar, Dist- Jalpaiguri 3) Jayanta Saha (M/27) S/O- Jaydev Saha of Bidyachakra Colony, W/No.44, P.S - BhaktinagarDist- Jalpaiguri and other for creating nuisance in public place, omitting the direction of on duty Police personnel, causing hurt to deter public servant from his duty and threatening Police personnel under proper section of law.
