In producing herewith one arrested person namely Chandra Barman (23 yrs approx), S/O- Avinash Barman of Parimal Nagar, PO+PS- Matigara, Dist- Darjeeling along with seized vehicle displaying Reg. No. WB 78 0814 loaded with riverbed materials(Sand), I ASI Chandra Prakash Adhikari of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 27.12.2025 at 03:20 hrs, during night special van duty along with force received an information from reliable source that one TATA Truck vehicle loaded with illegally mining riverbed materials is coming from Rana Nagar towards Matigara Hospital More. On receiving the information I along with forces rushed to the spot to work out the information. Under information and kind order of I/C Matigara P.S on arrival at near Matigara Hospital More under Matigara P.S area at around 03:35 hrs on 27.12.2025, I found one TATA Truck vehicle displaying Reg. No. WB 78 0814 loaded with riverbed materials is coming towards Matigara Hospital More. Subsequently, I managed to stop the vehicle. The driver introduced his name and address as noted above. I asked the driver to produce valid documents / papers of the said riverbed materials. On being asked he produced one photo copy of Road E-Challan for sand/riverbed materials transport bearing E-Challan No. 3008793/T/25-26/261220253424/PS, in r/o vehicle no- WB 78 0814 where on the permission holder details it show that GP/WARD is PATHARGHATA but on being asked he admitted that he loaded the riverbed materials from the Rana Nagar Ghat. There was a sufficient reason to believe that the above noted accused driver/owner of above noted vehicle has procured the river bed materials illegally without any proper royalty/ papers as per rule, for selling clandestinely for their wrongful gain. Accordingly, I seized the above noted loaded TATA Truck vehicle displaying Reg. No. WB 78 0814 along with river bed materials and the photo copy of the Road E-Challan for sand/riverbed materials Transport which was produced by the driver under proper seizure list and brought the above noted vehicle at P.S. The whole process of search & seizure and arrest was made in between on 27.12.2025 at 03:45 hrs to 03:57 hrs. The whole process of seizure was made under videography. The video was conducted by C/523 Sanjit Kundu.

Therefore I pray before you a specific case may kindly be started against the driver/ owner of the vehicle namely Chandra Barman (23 yrs approx), S/O- Avinash Barman of Parimal Nagar, PO+PS- Matigara, Dist- Darjeeling and the seized vehicle bearing Reg. No. WB 78 0814 under proper section of law and arrange for its investigation.
