Respected Sir,

I, Miss Simran Rai, Daughter of Riwarz Rai, Presently residing at Salbari, P.O. -
Sukna, P.S. - Pradhan Nagar, Dist. - Darjeeling, would like to lodge this complaint that
my Principal viz. Zeenat Kaushar is the registered owner-in-possession of the land
measuring 17 Decimal, recorded in L.R. Khatian No. - 2451, under L.R. Plot Nos. -
1721 and 1724, situated at Mouza- Panchkelguri, within Police Station - Matigara, Dist.
- Darjeeling, by virtue of a registered Deed of Sale being Deed No. - 1 - 2001 for the
year 2024, having permanent, heritable and transferable right, title and interest therein.

Sir, on 02.12.2025, in the evening, some persons viz. 1. Md. Salman, son of Md.
Paniya, 2. Md. Nasirul @ Baisaku, son of Md. Mafizuddin, 3. Jahanara Begum, wife
of Md. Salman and 4. Monika Begum, all are residents of Panchkelguri, P.S. - Matigara,
Dist. - Darjeeling, have suddenly come to the aforesaid land of my Principal and with an
ill intention to grab the aforesaid land of my Principal, all the aforesaid persons have
broken the hut made therein by my Principal and thereafter, they have illegally set on fire
in the said hut, by pouring inflammable articles like petrol or kerosene for forcibly
grabbing the land of my Principal, using their muscle and money power.

Sir, there are several antecedents against the aforesaid criminals, who are well-
known gundas, land mafias and land grabbers of the locality and several criminal cases
are pending against them.

Sir, immediately after the aforesaid incident, some local peoples have informed
me, over telephone, regarding the aforesaid facts in details and thereafter, on the next
day, I rushed to the spot and seeing me there, the aforesaid persons have firstly chased me
and started demanding a sum of Rs. 10,00,000/- from me, as gunda tax, otherwise, they
threatened me that they will forcibly sell the aforesaid land of my Principal to other
persons.
