With due respect and humble submission I, ASI Subhash Bahadur Tamang of Matigara P.S. beg to submit that today on 27/12/25 myself along with force were detailed to perform Mobile Patrol duty from 08:00 hrs vide C.C. No. 2821/25, Dated 27/12/2025 and GDE No. 1447. During my said mobile patrol van duty at about 12:30 hrs on 27/12/25, I got source information that one Tractors loaded with river bed material are coming towards Phansidewa More from Tarabari side, P.S. Matigara, having no document with them. Accordingly I informed the matter to I/C Matigra P.S., over phone. After hearing the information he directed me verify the veracity of that information at once. Accordingly I along with force rushed to Phansidewa More Railway Bridge. We found 01 (One) Tractors fitted with trolley loaded with river bed materials is coming towards Phansidewa More, Railway Bridge. Seeing the Police team from far, Driver/Owner of said Tractor jumped away from his Tractor keeping the Tractor in abandoned condition on the road. It may be presumed that the Driver/Owner of said Tractor procured the loaded riverbed materials, illegally and dishonestly from elsewhere, stealing by unfair means, for their wrongful gain and proceeding to deliver the same to their designated customer. I tried hard to trace out the Driver/Owner of said Tractor but in vain. Nobody came forward to claim the said Tractor. Finding no other alternatives I seized the Tractor with Trolley, loaded with river bed materials bearing Regn No. (i) T.C. 91, in presence of available witnesses, preparing proper Seizure List. I brought the seized Tractor to Matigara PS. Search/Seizure were made in between 12:41 hrs to 12:45 hrs on 27/12/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the Driver/Owner of Tractor fitted with Trolley bearing Regn. No. (i) T.C.- 91, loaded with river bed materials, and arrange for it's investigation.
