Subject: Complaint regarding criminal trespass, attempt to murder, assault, outraging modesty, damage to property, and intent to commit dacoity on 28.12.2025

Sir,

I, Kadhmoel Sharma, S/o Sidhi Prasad Sharma, resident of Dhukuria Jote, near G.D. Goenka School, do hereby lodge this complaint for your kind information and necessary legal action.

I am the tenant in the house of Advocate Vikash Lohani. That today i.e 28.12.2025 at about 7:00 to 8.00 pm, while I was present at my house on the ground floor, three to four unknown persons arrived outside my main gate on a Royal Enfield motorcycle bearing registration number WB 74 AN 8825. They started calling out loudly and using filthy and abusive language.

One of them asked about Vikash vena in an aggressive manner. I informed them that Vikash vena is outside. They then insisted that I open the gate, stating that they had some work. When I opened the gate, they forcefully attempted to enter my house, upon which I started shouting for help.

Hearing my cries, Pratima Didi, W/o Vikash vena came down through the staircase. At that moment, one of the accused suddenly took out a sharp cutting weapon (khukuri) and threatened loudly that "today I will kill Vikash at any cost." When we tried to stop them, one of the accused assaulted me and Pratima Didi, causing fear and injury.

During the scuffle, Pratima Didi recognized one of the assailants as Kumar Lama, S/o unknown, resident of Patherghatta Road, near Sri Sri Academy who took out Khukuri. The accused persons also damaged my garden, used criminal force against Pratima Didi, and attempted to outrage her modesty, clearly showing their intention to commit dacoity.

Due to our resistance and acting in self-defense, we managed to save our lives. After being identified, the accused persons fled from the spot, leaving behind their motorcycle. I immediately informed the police, and the police subsequently took the said motorcycle.

The acts of the accused clearly disclose offences of criminal trespass, attempt to murder, assault with deadly weapon, outraging the modesty of a woman, mischief causing damage to property, criminal intimidation, and attempt to commit dacoity. Their actions have caused serious fear and insecurity to me and family.

I therefore humbly request you to kindly register an FIR against the said accused persons, Kumar Lama, and others under appropriate provisions of law, investigate the matter thoroughly, arrest the culprits at the earliest, and ensure our safety.

Kindly take immediate and strict action.
