**Subject:** Complaint against my husband for continuous domestic violence, mental and physical cruelty, threats to life, and dowry-related harassment.

Respected Madam,

I, **Ruma Roy**, wife of **Saikat Laha**, daughter of **Prabir Roy**, presently residing at **Rankutir (Ground Floor), C/O Prabir Roy, Ustad Amirkhan Sarani, Ward No-30 of S.M.C., Deshbandhupara, District-Darjeeling, Siliguri-734004**, most respectfully submit this complaint seeking protection and legal action against my husband for his continuous cruelty, abuse and violence inflicted upon me throughout my married life.

My social marriage with **Saikat Laha**, son of **Tapan Kumer Laha**, resident of **Rankini Complex, Dayal Market, Jadugoda, Jharkhand - 832102** was solemnised on **24.11.2018** and our registry marriage was completed on **25.11.2018** at **Alipurduar**. Out of this wedlock, my son **Rihaan Laha** was born on **14.07.2023**. Since the very inception of my marriage, I have been subjected to constant verbal abuse, mental torture and physical violence by my husband. He has severe anger and behavioural issues and is habitually rude, aggressive and insensitive towards me. He continuously taunts me, shouts at me, misbehaves with me and humiliates me in a manner that has completely shattered my mental peace.

I am a **working woman and a breastfeeding mother**, yet my husband has never shown any concern for my physical or emotional well-being. Due to breastfeeding and childcare, I have been suffering from extreme sleep deprivation for the last two years. Despite my repeated explanations, my husband forces me to wake up early in the morning **every day**, humiliates me if I wake up later, and repeatedly says that additional sleep will not help me anyway. He deliberately ignores my health condition and uses this issue daily as a means to mentally harass and insult me.

My husband frequently accuses me of not taking care of household responsibilities such as cooking, grocery shopping or cleaning, despite fully knowing that we have a cook and a maid, that grocery shopping is done jointly or online, and that I manage my job as well as childcare responsibilities. I also share household expenses equally on a 50-50 basis, even though his parents stay with us round the clock. These false allegations are made only to demean and mentally torture me. During arguments, he also disrespects, insults and verbally abuses my parents and my sister, often making derogatory remarks about my upbringing and education. My father, who is a retired railway employee, has been repeatedly insulted and taunted by my husband.

During the first year of my marriage, while my husband was in the USA, I stayed with my in-laws in Bangalore at S.G.S Dreamland, Flat No-T7, 3<sup>rd</sup> Floor, C/O- Saikat Laha, Beml Layout 5<sup>th</sup> Stage, Raja Rajeshwari Nagar, Pin- 560098, Karnataka and bore almost the entire burden of household expenses, including maid's salary, electricity bills, television recharge, mobile recharges of my in-laws, grocery expenses and household repairs. I also took full responsibility for taking my in-laws to medical check-ups every weekend. Any expense my husband ever incurred on me was projected as a favour, whereas all my financial contributions were treated as my obligation.

Instead of appreciation, I was subjected to severe humiliation by my husband. My husband has also been physically violent towards me on several occasions. He has slapped me repeatedly, thrown a water-filled bottle at me and has bitten me brutally, even in the presence of my parents and his parents. One serious incident occurred in Bangalore when my son, who was about one year old, fell from the bed while playing with my husband and his lower lip started bleeding. Instead of accepting responsibility, my husband blamed me, alleging that I was busy eating. When I objected to this false accusation, he continuously slapped me in front of my parents until my mother intervened and stopped him.

After this incident, when I tried to dial 100 or go to the police station for help, my husband snatched my mobile phone and locked the main door and balcony door, thereby confining me inside the flat so that no one outside could hear or come to my rescue. When my parents tried to take me with them for my safety, my husband told my father, "You can take your daughter, but Rihaan will stay with me." This threat deeply traumatised me.

My husband repeatedly threatens to kill me whenever there is an argument and warns me to be careful before speaking. He frequently threatens to divorce me and force me out of the house. I am living under constant fear for my life.


My husband visited my parental home presently at Ramkutir (Ground Floor), C/O Prabir Roy, Ustad Amir Khan Sarani, Ward No-30 of S.M.C., Deshbandhupara, District-Darjeeling, Siliguri-734004, during 10.07.2023 to 22.07.2023, at the time of the birth of our son, and again from 01.11.2023 to 03.11.2023. During these visits, he repeatedly tortured me, beat me in front of my parents, used filthy and abusive language, and also threatened me and my family members inside my parental home.

Whenever my son gets injured while under my husband's supervision, he never accepts any fault. However, had the same happened under my care, I would have been blamed mercilessly and my parents would have been insulted by saying that they taught me nothing, that I lack common sense, and questioning how I even completed my engineering degree. He expects blind obedience and insists that I should never raise my voice against my husband, irrespective of his abusive behaviour. My husband has extreme anger issues. He throws food on the floor, rudely scolds the cook, breaks household articles and behaves in an inhuman manner whenever things are not as per his expectations.

At the time of marriage, causing severe financial strain to my parental family. I am now mentally, physically and emotionally exhausted. I have suffered continuous abuse, humiliation and fear since my marriage and apprehend serious danger to my life and dignity, as well as to the safety of my minor child.

I therefore humbly pray that you may kindly register my complaint and take appropriate legal action against my husband under the relevant provisions of law, provide me necessary protection, and ensure justice for me and my child.
