Sir,

I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Deb Narayan Ghosh (Present user, Ph No-8617304017), S/O- Sambhu Nath Ghosh, 146, Balai Das Chatterjee Road, Ward No.16, Hakimpara, Siliguri, Dist-Darjeeling, Pin-734006 for having committed offence as stated here under.

On 29.12.2025 at about 1:40 PM. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Sambhu Nath Ghosh and inspected service installation, metering installation of Consumer ID **412151873** in the name of Sambhu Nath Ghosh. During inspection it was found that Deb Narayan Ghosh (Present user) is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 10.11.2025 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 20322.00 (Rupees twenty thousand three hundred and twenty-two only) including the LPSC of Rs. 340.00 (Rupees three hundred forty only) till the date of 29.12.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Bentec Electricals & Elec Ltd, serial no.- **IPB224277** installed against Con Id. **412151873**, seized by preparing a formal seizure list duly signed by witnesses.

As Deb Narayan Ghosh (Present user) have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
