Sir,

I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Susmita Ghosh (Ph No-8670840943), w/o- Ananda Saha, Nani Kuthir, J.C.Bose Road, Hakimpara, Ward No-17, P.S.-Siliguri, Dist-Darjeeling, Pin-734006 for having committed offence as stated here under.

On 29.12.2025 at about 1:40 PM. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Susmita Ghosh and inspected service installation, metering installation of Consumer ID 403092059 in the name of Susmita Ghosh. During inspection it was found that Susmita Ghosh is using electricity unauthorisedly & illegally by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 28.05.2025 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 12460.00 (Rupees twelve thousand four hundred and sixty only) including the LPSC of Rs. 765.00 (Rupees seven hundred sixty-five only) till the date of 29.12.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Himachal Energy Pvt Ltd, serial no.- HE0051950 installed against Con Id. 403092059, seized by preparing a formal seizure list duly signed by witnesses.

As Susmita Ghosh have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the deemed disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
