Respected Sir,

I, ASI. Anupam Roy presently posted under your kind disposal lodging this written complainant against one Namita Chakraborty, President Paschim Banga, ASHA (ACCREDITED SOCIAL HEALTH ACTIVIST) Kormi Union, Darjeeling District Committee, Joy Lodh, President AIUTUC, Darjeeling District Committee along with 450 to 500 other ASHA Kormi Union, Darjeeling District Committee to the effect that on 31.12.2025 at 14.05 hrs during my CS-I patrolling van duty vide MCC No- 1860/25 Dated-31.12.2025 I received an information that leaders and supporters of ASHA Kormi Union, Darjeeling District Committee will bring out a rally from Bagha Jatin Park under Siiguri PS to Sub-Divisional Office, Pradhan Nagar under the leadership of Namita Chakraborty, President Paschim Banga, ASHA (ACCREDITED SOCIAL HEALTH ACTIVIST) Kormi Union, Darjeeling District Committee and Joy Lodh, President AIUTUC, Darjeeling District Committee. Accordingly I informed the matter to you as well as superiors. As directed by you myself along with ASI. Sanjay Basunia and force of Siliguri PS left for Air View More, Siliguri.

On arrival at Air View More, Siliguri at about 14:25 hrs I found approx 450 to 500 members of ASHA Kormi Union, Darjeeling District Committee coming towards Air View More from Sevok More Side through Hill Cart Road. When they reached at Air View More found they holding the rally under the leadership of Namita Chakraborty, President Paschim Banga, ASHA (ACCREDITED SOCIAL HEALTH ACTIVIST) Kormi Union, Darjeeling District Committee and Joy Lodh, President AIUTUC, Darjeeling District Committee on their various demands. On arrival at Air View More, Siliguri the members of the rally started raising slogans and shouting, immediate after that they became agitated and they started blocking the Airview More, Siliguri and some of the members and leaders sit in the middle of the road a result both flanks of the Hill Cart Road got stacked which causes obstruction in the free flow of traffic.

Seeing the situation going out of control myself along with other officers and force intervene the situation and also tried to make them understand that in this busy hours their act obstructing the free flow of the traffic and creates inconvenience and also I asked them whether they has any valid permission for holding this rally in this busy hours. The leaders and supporters failed to produce any permission regarding the rally. Then I stated them that they assembled in an unlawful manner and for their act free flow traffic of the city has been obstructed by their demonstration. I also direct Namita Chakraborty, President Paschim Banga, ASHA (ACCREDITED SOCIAL HEALTH

ACTIVIST) Kormi Union, Darjeeling District Committee and Joy Lodh, President AIUTUC, Darjeeling District Committee to move on from the spot along with their supporters as they are assembled unlawfully and illegally obstructing the road. After 15 minutes finally I able to make them understand and the leaders and supporters of Rally withdraw their sit in demonstration and moved on from Air View More, Siliguri and went towards Pradhan Nagar through Hill Cart Road.


