In producing herewith one arrested accused person namely Abishek Biswakarma-25yrs s/o Purna Bahadur Biswakarma of Mangchu Forest village, Rongpo, PS Kalimpong, Dist Kalimpong along with the following seized articles as per proper seizure list:

1. 282 (Two eighty two) bottles of Old Monk XXX Rum each bottle containing 180 ML (Total-50.760 liters) on which one bottle taken as sample marked as Exhibit-A1
2. 24 (Twenty four) bottles of ROYAL STAG whiskey each bottle containing 750 ML. (Total-18 liters) on which one bottle taken as sample marked as Exhibit-B1
3. 12 (Twelve) bottles of Magic Moments grain Vodka each bottle containing 750) ML on which one bottle taken as sample marked as Exhibit-C1
4. 12 (Twelve) bottles of Magic Moments grain apple Vodka each bottle containing 750) ML on which one bottle taken as sample marked as Exhibit-D-1
5. 90 (Ninety) bottles of OLD MONK deluxe XXX Rum each bottle containing 750 ML (Made in Sikkim) on which one bottle taken as sample marked as Exhibit-D-1
6. One six wheeler Tata Ultra Truck having Registration No-SK04D/0133

I beg to report that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted person to the effect that on 30.12.25 at 18.20 hrs received a secret source information from Eastern bypass, near "ALLEN" under Bhaktinagar PS that one Tata Truck loaded with huge liquor bearing Registration No-SK04D/0133 was coming from Sikkim towards Eastern bypass for transporting the same in Siliguri for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1594 dated 30.12.25. As per your kind instruction myself along with ASI Dipak Karmakar, ASI Khagen Barman, ASI Dhrubo Misra, C/374 Debraj Biswas and PS mobile van officer PSI Sahanur Rahaman (K-37) with force proceeded to the Eastern Bypass to work out the information with investigation kits vide Bhaktinagar PS GDE No-1595 dated 30.12.25.

At 18.40hrs we reached at the spot at Eastern bypass, near "ALLEN" and on the way I convinced the available public who were present at that time, following two persons came forward to accompany us for conducting search & Seizure if required, the details of individuals are (1) Narayan Roy s/o Pabitra Roy of Shivanagar, Eastern bypass, PS Bhaktinagar Dist Jalpaiguri and (2) Rohit Roy s/o Jogesh Roy of Chayanpara Pipe Line PS Bhaktinagar Dist Jalpaiguri. After reaching the spot we are waiting there and after sometimes found that one Truck bearing No-SK04D/0133 was coming from Sikkim side towards Eastern bypass side. We detain that Truck and recovered the above noted articles from the possession of the above noted person which was kept in backside of that Truck. During enquiry it came to learn that he was transporting the same to Siliguri for his wrongful gain without any valid documents/license in c/w celebrations of new year. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and label, also arrested him after maintain all formalities. Inform him about Ground of arrest in written. The whole process of search & seizure has been captured in audio & video records.. (The seizure was made in between 20.15 hrs to 22.05hrs)

I therefore request you a specific case may kindly be started against the accused persons namely Abishek Biswakarma-25yrs s/o Purna Bahadur Biswakarma of Mangchu Forest village, Rongpo, PS Kalimpong, Dist Kalimpong under proper section of law and arrange for investigation..
