Sub – Prayer to start an FIR in proper section of law.

Respected Sir

With due respect and humble submission I beg to state that during my RT night duty on 30/12/2025 myself along with C/ 422 Chandan Murmu and C/ 1189 Rajendra Lakra in govt vehicle vide C.C.no- 6192/25 Dt 30/12/2025 at about 00:05am I been informed to help ASI Passang Dawa Sherpa who was performing naka duty at Tri Junction with force vide C.C No- 6201/25 Dt 30/12/25 . At about 00:25hrs (Dt 31/12/25) we found that one EICHAR vehicle Bearing number AS 01 SC 1539 which was coming from check post towards Salugara with a dangerous speed and reckless driving . At Tri Junction we manage to stop the said vehicle and on seeing police party the driver try to bunk away , police party manage to apprehended him . On asking he stated different statement in different times , The Eichar vehicle was fully covered by plastic tripal as from the out side no one can guess what is inside the vehicle. On searching we found live stocks ( Cows +Calfs) those were inside the said Eichar vehicle in a pathetic and inhabitable condition. On asking the driver could not show any valid documents of the said live stocks neither any supportive documents of the vehicle.

Accordingly after consulting with my superior I seized the said Eichar vehicle Bearing number AS 01 SC 1539 along with all the live stocks ( Cows-14 + Calf-10) time from 00:45Am to 01:25Am dt 31/12/25 maintaining all formalities with video recoding . After seizure I consult with nearest farm which own by Mr Jahangir Alam S/O Ujir Ali of Amai dighi , Ful;bari PS NJP and hand over the live stocks (Cows -14+ Calf's -10) maintaining all formalities as zimma. He promised to take care all the live stocks ( Cows -14 + Calfs-10). The said driver of Eichar vehicle Bearing number AS 01 SC 1539 namely Jai Prakash Singh (38) S/O Lt Dhanpad Singh of Vill- Baajitpur malahi Po- Bidupur railway station PS- Bidupur Bazar Dist – Vaishali State – Bihar pin -844502 being arrested on 31/12/2025 at 02:35 Am maintaining all NHRC guideline . On interrogation the said driver confess that the live stocks were brought from Bihar and was going to Meghalay for selling.


