Subject : Complaint against attempt to Murder

Sir,

I Smt Manshi Hazra , wife of Sri Santoshj Hazra a resident of Barivasa , Madani bajar, PO PS - NJP , beg to state before you that yesterday night at around 10:40 pm when my husband was returning from work he stopped at a food stall opposite to Gairkata FL shop where he ordered to pack fish fries to take them to home at that time the following course of events happened .

1. One person standing beside him in drunk condition whom he can identify as Prabir Mandal of thakurnagar knowingly pushed my husband .
2. On confrontation when my husband asked the reason and he started to verbally abuse my husband with filthy slang languages and started pushing him repeatedly.
3. Trying to save him from the assault my husband tried to block his hands then he suddenly punched him and when he fell down on the ground Prabir Mandal took out his mobile phone and called his associates to come to the place of occurrence.
4. Within 3-5 minutes of his call one Krishna Mandal of Thakurnagar came with 10-12 associates whom my husband couldn't identify but all of Thakurnagar Club came there with iron rods , sharp weapons and sticks .
5. In no time they started assaulting my husband saying "ajke toke merei felbo" and dragged him to the ground hitting him with the rods , sticks and also tried to stab him with a sharp object which he blocked .
6. After 4-5 minutes of beating my husband almost turned unconscious when few local people's gathered when he was lying on the ground in a pool of blood which was coming out from his head as his head sustained injuries due to the assault with iron rod.
7. Upon seeing the gathered public the miscreants left my husband and fled the spot and while leaving they snatched his wallet and took the cash containing which is approx 5700 rupees.
8. Then some kind hearted persons took my husband to the siliguri district hospital where he got treated and the doctor suggested to admit him .

9. He got discharged today from the hospital and came back home .

This is a clear case of criminal intimidation , public nuisance , deliberately causing hurt, catching and attempt to Murder , I hereby leave it to your good book of law to look into the matter and take the necessary legal action so that the miscreants get the proper punishment as they are leaving in a state of fear remembering the terror ful night and the injuries I sustained in the same . Please do the needful and oblige.
