With due respect, I SI Madan Rishi presently attached with New Jalpaiguri Police Station, Siliguri Police Commissionerate under your kind control beg to state that on 30/12/2025 I was detailed as Night Kelvin 40 Mobile Van under NJP PS along with C/733 Alok Das and C/1055 Gobindo Roy Roy vide NJP PS MCC No-660/25 Dated 30/12/2025. During my mobile van duty on 31-12-2025 at around 01.00 Hrs I received an information from the duty officer of New Jalpaiguri PS regarding one accident took place at Noukaghat under NJP PS. Accordingly I had been to the spot and found that one Scooty bearing no WB 74 BF 3818 is lying near by divider and as per the local witness it came to learned that the rider of the scooty itself dashed the divider due to rash and negligence driving. During this incident the rider of the Scooty bearing Registration No WB 74 BF 3818 namely Arjun Mandal (b)/o Srikanta Mandal of Purba Dhantala, Binnaguri, PS New Jalpaiguri Jalpaiguri received injuries and with the help of local we immediately moved him to Siliguri District Hospital for his treatment.
