Subject: FIR regarding Theft, Physical Assault, Criminal Intimidation, and Extortionate Threats.

Respected Sir,

I, **Priyanka Devi**, W/o Ankur Kumar, resident of Baghajatin Colony, Near Ramkrishna Ashram, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, do hereby lodge this formal complaint against **Uttra Roy**, D/o Khoka Roy, resident of Ramkrishna Para, P.S. Matigara, and her unidentified associates, for the following offenses:

That I am the proprietor of a footwear shop, "**Chic Kicks**," located in the basement of City Centre Mall, Matigara. On December 20, 2025, the accused, **Uttra Roy** (who runs "**Beautinica**" Spa nearby), entered my shop, took a pair of sandals, and walked out without payment or consent. When my staff confronted her, she refused immediate payment, promising to pay later that evening, which she never did. That On December 27, 2025, at approximately 7:20 P.M., when my staff requested payment, the accused became violent and used foul language. When I arrived to mediate, she physically assaulted both me and my staff. Upon the arrival of my husband, **Ankur Kumar**, the accused attempted to lure us into her spa to "**settle**" the matter. When we refused, she threatened to frame my husband in a false case of rape and molestation and issued a death threat against me and my family. That on December 29, 2025, at 3:00 P.M., under the pretext of a mutual settlement, the accused called us to a location near **Uttorayon**. There, she and five of her colleagues (three men and two women) launched a premeditated attack. **Uttra Roy** repeatedly slapped my husband, and her associates joined in beating us when I tried to intervene. That despite bringing this to the attention of the City Centre Mall Management, no action has been taken, and we continue to live in fear for our lives and livelihood.

Therefore in the light of the above facts, I earnestly request you to register an FIR under the relevant sections of the Bharatiya Nyaya Sanhita (BNS)—including provisions for theft, causing hurt, and attacks by several people and initiate a prompt investigation to ensure our safety.
