
1. One multi colour camouflaged shirt, look like as Army Uniform
2. One Olive Green Jacket for winter, look like as Army Uniform
3. One survival bracelet
4. One Black coloured Mobile Phone, having SIM No. 9933148764/7586079370 and IMEI No. 86826107139960/86826107139943. Realme.
5. One pair black coloured shoe, size - 9, styled as "Active Original"
6. One Cloth nameplate styled as B. GHATANI

I, SI Nirmal Kr. Das presently posted as O/C Uttarayan O.P. under Matigara P.S. Siliguri Police Commissionerate under your kind control beg to state that 31/12/2025 at about 18:45 hrs I received source information that one person is loitering suspiciously at City Centre Mall under P.S. Matigara wearing uniform of Indian Army and that person is likely to be fake. Accordingly I diarised the fact in G.D. vide Matigara P.S. GDE No. 1738, Dated 31/12/2025 also inform the information to I/C Matigara P.S. SPC. Hearing the information I/C Matigara P.S. directed me to verify the veracity of the information at once. As per his direction I along with ASI Subhash Bahadur Tamang, ASI Md. Jamal Mia C/585 Hitendra Nath Roy, VP/04 Dipak Barman, all of Matigara P.S. left P.S. for City Centre under Matigara P.S. to work out the information vide Matigara P.S. GDE No. 1740 Dated 31/12/2025. At about 17:55 hrs we reached at City Centre also contacted with my source. As indicated by my source we reached in a shop styled as "DECATHLON", situated at City Centre, Matigara and found that one person in Army Uniform is moving in and around the said shop. I asked him to produce his Unit identity Card which he failed. On doubt I again asked his name and address as well as his Rank and Unit name. In reply he disclosed his name and address as noted above and confessed that he is not an Army personal and he used to put on such fake Indian Army uniform to impress his friends and others. As City Centre is a public place and not a suitable place to seize his Wearing Apparels, maintaining his dignity/decency I took his photographs in said uniform and decided to seize his fake uniform at Matigara P.S. Accordingly I arrested him u/s 35 of BNSS to prevent him to commit any cognizable offence.

I brought him at Matigara P.S. also seized the above noted articles. Search & Seizure was made in between 21:13 hrs to 21:25 hrs on 31/12/2025 at Matigara P.S.

Under the above circumstances I pray before your kind honour that a specific case may kindly be initiated against arrested accused namely Bhawesh Ghatani (24) S/O Bhupendra Ghatani of Rajbari, Naray Busty P.S.- Sadar, Dist.- Darjeeling and arrange for it's investigation.
