Subject: Complaint regarding house-breaking and theft

Sir,

I, Debabrata Barman, presently residing at Near Teak Bagan, Middle Palash Road, Debidanga, Champasari, Siliguri – 734003, opposite Judge's House, am writing to state as follows:

I state that my wife and I had gone to my house at Islampur on 24th December after locking my residence at Debidanga and remained there till 26th December. Upon returning to my house on 26th December, I found that the grill of the interior front gate had been cut, indicating forcible entry into the house.

After entering the house, I noticed that several valuables and cash were missing. I then checked the house carefully, verified the missing items, and enquired with neighbours to ascertain whether anyone had seen or heard anything suspicious. The following articles were found to be stolen:

- One gold chik
- One set of gold earrings
- One gold finger ring
- One set of gold sakha pola
- Three gold nose pins
- One silver bracelet
- One set of silver payel
- One silver chain
- One silver ring
- Cash amounting to ₹60,000/-

From the circumstances, I believe that the incident took place on the night of 25th December, when the house was locked and unattended.

The delay in lodging this FIR has occurred as I was initially busy assessing the loss, confirming the missing articles, and making enquiries with neighbours and family members. The complaint is being filed at the earliest possible opportunity after ascertaining the facts.

I humbly request you to kindly register this complaint as an FIR, investigate the matter, and take appropriate legal action against the unknown miscreant(s), as well as assist in the recovery of my stolen property.

I shall cooperate fully with the investigation.
