Subject: Complaint regarding assault and criminal intimidation.

Respected Sir,

I, **Sri Raju Saha**, son of **Later R. N. Saha**, resident of **2nd Mile, Jyotinagar, Sevoke Road, under P.S. Bhaktinagar, District Jalpaiguri**, do hereby beg to state as follows:

That today, in the evening at about 7:20 PM, while I was returning with my family members in my **Toyota car bearing Registration No. WB 74 AP 7000**, and when I reached opposite to **Monginis Cake Shop situated on Nivedita Road, Pradhan Nagar**, one unknown person driving a **black Safari car bearing Registration No. WB 74 BQ 3139** suddenly came in front of my vehicle and forcibly stopped my car.

The said person started abusing me with filthy and obscene language and aggressively attempted to open the gate of my vehicle with the intention to **assault and kill me**. He also tried to assault my family members who were present in the car, including my **aged mother** (78 years old), two child, one is 3years old and another is 1 and half years old and my wife.

When I protested against his illegal acts and requested him to stop, considering the presence of my elderly mother, the said person became more violent. He forcefully tried to open the doors of my car and **caused damage to my vehicle at several places**. Thereafter, I came to know from the local people present at the spot that the name of the said person might be **Sontu Das, son of Shibal Das, R/o Near Margaret School, Nivedita Road, Pradhan Nagar**.

The actions of the said person caused severe fear and mental trauma to me and my family members and posed a serious threat to our lives and safety. I therefore request you to kindly register an FIR against the said person under appropriate sections of law and take necessary legal action at the earliest.
