Sub - FIR under section 354 - 354(A), 148 IPC complaint.

I, Miss Kirti Sahani, d/o Kamalchya Kant Sahani aged 24 yrs resident of Bagayatri colony do hereby lodge this complaint for registration of an FIR against Rahul Mahato, Jitendra Mahato, Jitendra Chauhan, Vicky Mahato s/o Ram Ulesh Mahato, resident of Bokajote and his family persons with some unknown people.

That on 30th Dec. 25 about 10:30pm, I was returning home from work and when I reach tea Auction Road, the accused approached me, wrongfully restrained me and harassed me with the intention to outrage my modesty. The accused "Jitendra Mahato" tried to assault me after resisting he started hitting me and my father Kamalchya Kant Sahani and my friend Aditya Raj Sahu as I called them. During this rampage the accused people started to hit the car with iron rods and bricks causing damage to the vehicle. They hit us and damaged our car causing trouble to us and our belongings including 2 Gold ring and earrings were lost. He used obscene words / Gestures. Due to this act I am mentally traumatized & felt unsafe. The incident occurred in a public place, causing fear and humiliation.

Therefore, I request you to take strict actions against all the accused and launch my FIR.
