Advocate Siliguri Court, ~~Room~~ Room no-8, would like to lodge a complaint against 3 miscreants having a four wheeler vehicle bearing no WB74 ~~BL3596~~ BL3596

It is pertinent to mention here that I along with my husband were going to drop my friend Dipse Mishra (Advocate) to her residence at around 4:30 am on 1st of January 2026 to Raj Bihari Sarani, in between the road when we were going towards Kuleghar more from children Park, those three miscreants with two girls were blocking our way opening the door of the vehicle, when we asked them to give us the ^{way} road, they started using filthy language and suddenly started touching me and my friend in ~~our~~ my body outraging ~~the~~ my modesty and the boy with the brown jacket grabbed my husband jacket and asked for 1 lakh money, also there were 2 girls/ladies who were severely drunk and were shouting "ook dhov" "madarchod ke taka chao" "lousa" were the words using by a girl who was wearing black jacket and skirt.

When my husband came out of the vehicle and started saving my us and then they started pulling me from my second seat and when I ~~was~~ ^{was} forced / ~~was~~ ^{was} tried saving me; one man fair

face with bald head pushed me towards wall to intending
to kill me ~~was~~ because he pushed me towards wall
forcefully with my head in the front, but my left feet
got stuck and I fall down having which caused a
severe pain and I am unable to walk now also one
boy with brown jacket had ruckles in his hand and
he hit me in my left middle finger which I am
seriously injured (medical slip is attached).

It is important to note that my friend was
pulled from the window of the vehicle grasping her
head and hair by those three miscreants and
those two girls, who were totally drunk and
even were unable to walk also.

later when we somehow fled away from
the clutches of those five persons, ~~others people~~ had
us ~~beating~~ and went to the Siliguri District Hospital,
those boys came along with many other boys to look
for us, ^{also provoked us} where we had to call the Siliguri traffic
police and later came and lodged the FIR.

It is clear from their intention / intent
to touch my body specially the upper part they
touched which was very shameful for me also ~~abridging~~
the my modesty also touching my friend pulling her
from her head from the window of the vehicle and asking
money to my husband I catch ripples with blackmailing
by those two girls and when not given those three
boys tried to kill me pushing me forcefully towards
wall over head. I request the concerned authority to take
immediate legal steps.
