With due respect and humble submission, in producing herewith 04 (Four) arrested accused persons namely i) Samim Aktar (30) s/o Pajir Uddin of Ilubari, PS-Islampur, Dist.- Uttar Dinajpur (ii) Jiyaul (38) s/o Samsuddin of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iii) Md Kaif (22) s/o Md. Rajjak of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iv) Saraman Yadav (40) s/o Lt. Ramilash Yadav @ Rambilash Yadav of Kholai bhaktari, Mathapari, , PS-Matigara, Dist.- Darjeeling along with following seized articles:-

I, ASI Amit Lama presently posted at Bagdogra PS, Siliguri Police Commissionerate would like lodge a written complaint against the above mentioned 04 (Four) arrested accused persons to the effect that on 30.12.2025 myself along with C/1509 Sourav Roy Sarkar and VP/01 Pradip Roy were detailed to perform night PC Mobile van duty under Bagdogra PS, SPC area with arms and ammunition till 31.12.2025 at 0700 hrs vide This refer Bagdogra PS GDE No.-1420 dated:30.12.2025.

While performing night PC mobile van duty at about 0015 hrs on 31.12.2025 I received an information that one red color DCM eicher vehicle coming from Islampur Side and proceed towards Siliguri Side with tempering number plate with the motive to commit cognizable offence. Accordingly to verify the veracity of the information myself along with force with the assist of RT Mobile Van officer namely ASI Balaram Roy started Naka Checking at Bihar More, under Bagdogra PS, Dist.- Darjeeling and at about 0045 hrs we found that the one Red color DCM Eicher vehicle displaying number Plate in front side AS/01TC/2779 and AS01TC/8778 in rear side of vehicle followed by one Bolero Scorpio bearing registration No. WB/74B/2019 coming from Islampur side and proceed with siliguri side with high speed. All of a sudden I found that a big vehicle stopped at Gossaipur crossing the railway underpass bridge and a small vehicle also stopped at the same time. The driver of the small vehicle came out of the vehicle and was communicating verbally to the driver of the big vehicle. Seeing this Police Team tried to approach them but seeing this both the vehicle tried to fled away from the spot. We signal them to stop the vehicle but after seeing the police team they fled away from the spot after a hot

chase we successfully apprehended both the vehicle at Gossaipur, Uttora Gate No.01, AH-2, PS- Bagdogra, Dist.- Darjeeling. Accordingly, we apprehended all the four person boarded in the vehicle and on being asked they give different statement in different time. On further interrogation they disclosed their name and address as noted above. On further interrogation they admit their guilt and stated that they stole the vehicle from Assam area and proceed to Bihar for its clandestine disposal and to evade from Police, we tempered the number plate of Eicher of vehicle bearing registration No. AS/01TC/2779 to as AS01TC/8778. On further asked they failed to produce any valid documents of vehicle. Accordingly, I arrested all the 04 (Four) accused persons namely i) Samim Aktar (30) s/o Pajir Uddin of Ilubari, PS-Islampur, Dist.- Uttar Dinajpur (ii) Jiyaul (38) s/o Samsuddin of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iii) Md Kaif (22) s/o Md. Rajjak of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iv) Saraman Yadav (40) s/o Lt. Ramilash Yadav @ Rambilash Yadav of Kholai bhaktari, Mathapari, , PS-Matigara, Dist.- Darjeeling after observing all legal procedure and under proper memo of arrest. The ground of arrest is duly communicate with them on writing. and seized (i) One Red color DCM Eicher display number AS/01TC/2779 in front side and AS01TC/8778 in rear side of vehicle (ii) One white color Scorpio bearing registration No. WB/74B/2019 (iii) One Driving license in the name of Saraman Yadav having license No. WB7620100014423 under proper seizure list in presence of witnesses after signed by the accused persons. The whole process of search and seizure was made in between 0105 hrs to 0135 hrs and is conducted under proper videography.

Under this fact and circumstances, I prayed before you that specific case may kindly be started against i) Samim Aktar (30) s/o Pajir Uddin of Ilubari, PS-Islampur, Dist.- Uttar Dinajpur (ii) Jiyaul (38) s/o Samsuddin of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iii) Md Kaif (22) s/o Md. Rajjak of Balacha, PS- Islampur, Dist.- Uttar Dinajpur, (iv) Saraman Yadav (40) s/o Lt. Ramilash Yadav @ Rambilash Yadav of Kholai bhaktari, Mathapari, , PS-Matigara, Dist.- Darjeeling and others and arranged for investigation.
