I SRI Madan Barman, S/O Late Dhiren Barman, resident of Ashighar Colony, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, West Bengal, would like to draw your kind attention to the affect that yesterday night at about 11:40p.m. I went to Telipara, in order to look after construction work in my land and when I returned back at that time one 1. Gopesh Roy, S/o Kohita Roy, 2. Tapor Roy @ Tokor Roy, S/O Isnath Roy, 3. Sushanta Roy, S/O Krishna Roy, and some others antisocial person of Telipara, Noresh more blocked me and demand of money Rs. 50000/- and when I asked them as to why they demanded the same, at that time they told me that if I did not pay the same, they will break the Dhalai work in my construction. Thereafter when I clearly denied to fulfill their such type of Illegal demand at that time they attacked me by using Iron Road, Stones, Buttam, in order to kill me. From there such type of attack severe serious injury in my whole body. the aforesaid Gopesh Roy, Tapor Roy, and Sushanta Roy used their bikes key in order to blind me and attacked in my eyes. And for this presently I did not able to see anything. Thereafter some local people came to the spot and rescued me from their clutch. Thereafter some of my friend took me to the Siliguri District Hospital for treatment.

Sir this my humble request before your good self that kindly look after this matter and takes necessary legal action against the aforesaid culprits as per law.
