With due respect I **YASHODHA DAS** Daughter of Sri Ram Sundar Das, resident of Demdema, Under Dab Gram Panchyat I, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal) begs to state that on 31.12.2025 at about 10.00 P.M suddenly without any reason 1) **KALPANA SINGH** Wife of Indra Singh, 2) **DHIRAJ SINGH** Son of Indra Singh and 3) **INDRA SINGH** Son of not known all are resident of Demdema, Under Dab Gram Panchyat I, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal), the aforesaid persons forcefully enter into our place of residence with iron rod and sharp weapons and at that time sister Laxmi Das and my brother in law Ram Shankar Das was present. That they without any reason started beating my sister with feast & blow and iron rod. That my sister got grievous bleeding injury in her face and my sister started crying and raise voice for help, after heard the hearing of the voice of my sister, my brother in law come outside the room to protect my sister but the aforesaid person also beet my brother in law with iron rod and he sustain grievous bleeding injury in his body. That the intention of the aforesaid persons are intend to outrage my sister modesty and to kill her. That due to such assault my sister became senseless and the aforesaid persons thought that she died and they left the place with threat that if any one lodge the complaint before police then they kill our entire family. That I took my sister to Nayak Nurshing Home, Siliguri at midnight of 31.12.2025 and today I again took her to Nayak Nurshing Home, Siliguri for her treatment, my sister got 8 stitch on her lower lip. That they are very desperate in nature and every possibility that they again take the laws in their hand. (Copy of Medical prescriptions and injury photo of my sister, brother in law is annexed herewith).

That the aforesaid persons also attack upon my sister on 31.05.2025 and one written complaint was lodge before the Bhaktinagar Police Station being Bhaktinagar P.S Case No. 506/2025.

So, I therefore request before you to kindly look into the matter and do the needful under the provision of law and start specific case against the accused person. I shall be highly obliged for this act of kindness.
