Respected Sir,

I, Kalpana Singh, Wife of Sri Indra Singh, resident of Salugara, Demdema Busty, Dabgram Gram Panchayat- I, Post Office- Salugara, Police Station- Bhaktinagar, District-Jalpaiguri, PIN-734008 would like to inform you that on 31.12.2025 at around 10 p.m. there was a huge hue and cry in our neighborhood as Shankar Das and his wife Laxmi Das were fighting, Shankar Das was in an intoxicated condition and was mercilessly beating his wife with sharp iron rod and she is was in extreme pain. I along with my husband namely Indra Singh went to intervene with other villagers namely Prem Paswan, Sonikanth Roy, Shiv Paswan, Bablu Roy, Mithun Roy, Vicky Malo, Abhay Roy and others. When Shankar Das saw us he became more aggressive and attacked me and my husband, Shankar Das further called his family members namely Yashoda Das, Sita Das, Aniket Das and Arun Das who started to attack us ruthlessly as a result of which I and my family members were injured.

Shankar Das further physically assaulted me, pulled me by my hairs, grabbed my private parts inappropriately with an intention to outrage my modesty and while doing so he disrobed me. Shankar Das further pushed me on the floor as a result of which I fell down and sustained injury on my shoulder. Shankar Das, Yashoda Das, Sita Das, Aniket Das and Arun Das further abused me with filthy language and used racial slur to demean me my family members. I somehow managed to save myself from the clutches of Shankar Das, Yashoda Das, Sita Das, Aniket Das, Arun Das and other unknown persons who would have killed me had my family and other locals not intervened. Shankar Das, Yashoda Das, Sita Das, Aniket Das, Arun Das and their men and agents further threatened us that they would implicate us in false and frivolous case if I or my family members dared to report this incident before the police station.

Under the aforesaid circumstances I request you to investigate the matter and book the culprits namely Shankar Das, Yashoda Das, Sita Das, Aniket Das, Arun Das and other unknown individuals involved in the crime in accordance with the appropriate provisions of law and oblige.
