Subject: Complaint Against Misconduct, Rash Driving
by a drunk driver (WB 73E 4679)
Who hit our Car

Respected Sir,

I Sangeeta Lama, D/O Lt. Phurba Lama residing in Manakamna 7, Amber 40, Mahismari Debidanga, Siliguri would like to lodge a complaint regarding an incident involving rash and negligent driving followed by rude and aggressive behaviour of a drunk driver on January 1st 2026, time 19.15hrs near Maa Durga Petrol Pump, Debidanga. He drove in a rash and irresponsible manner, although there was no physical injury, the incident caused damages to our car and huge mental distress. His behaviour was highly unprofessional, confrontational conduct and intimidating in nature causing mental distress, to three ladies in the car.

Name-1) Sumitra Lama (mother, 85 years old)
2) Sushma Lama (sister, 60 years old)
3) Sangeeta Lama (myself, 58 years old).

My mother is a heart patient with pace maker and she was nervous, frightened and worried with this incident.

Our car was being driven by Ngawang Ponlop (my nephew), car no. WB74 BF2580 and the drunk driver was trying to hit my nephew through the driver seat window. Since my mother was traumatized, she stopped my nephew from stepping out of the car. So, I got out of the car to talk to the driver but he started to threaten and abuse me, took his phone to take a video of me coming very close towards me which led me to run away from him around our car, but he continued to invade my privacy and continued taking my video. He threatened saying 'TUM KO NAHI MALUM HUM KAUN HAI', 'KISSAY TAKKAR LAY LIYA'. He was calling someone on the phone talking in B... and it felt like he was calling people to deal with us. People near the shop (opposite Maa Durga) witnessing the driver's unruly and an uncouth behaviour towards me, advised us to drive away from the scene to avoid further interaction with the drunk driver.

Ten minutes after we drove away, at around 19:25 hrs, he reappeared near our car, honking loudly, not allowing other cars to pass by and disrupting traffic, displaying inappropriate gesture raising his middle finger to us.

His car over took us and then he started driving very slowly, so we also maintained a slow pace, not over taking his car to avoid being hit again by his car.


Finally, we stopped at Manakamna Junction, near a Medical Store (Narayani) familiar to us and I stepped out of the car to seek help. The people who intervened and interacted with the driver car no WB 73 E 4679 concluded that the driver was drunk and advised us to file a complaint against him in the said Police Station, as he was clearly harassing us. After hearing this, the driver shouted that he was a 'DADA' and no one could touch him. The driver was unapologetic and claimed that he is 'MARD KA BACHHA' and threateningly twisted his non-existent moustache.

I sincerely request you to kindly look into this matter seriously and take proper action against the driver, so that he doesn't threaten other ladies in future.
