With due respect, I am producing herewith the 05 (five) arrested accused persons namely 1] Md. Samir (21yrs approx), S/O- Md. Saidul of Tumba Jote, Beldangi, PO+PS- Matigara, Dist- Darjeeling, 2] Bishal Talukdar @ Bikram (27 yrs approx), S/O- Lt. Biswajit Talukdar of Sukanta Pally Gas Godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling, 3] Tarikul Islam @ Chhotan (24 yrs approx), S/O- Kalsar Alam of South Ambedkar Colony, PO+PS- Pradhannagar, Dist- Darjeeling 4] Joy Sarkar (30 yrs approx), S/O- Mahadeb Sarkar of Suryasen Colony, Block-B, W/NO-34, PO-Siliguri Town, PS- Bhaktinagar, Dist- Jalpaiguri and 5] Siddhant Prasad Nunia @ Subham (30 yrs approx), S/O- Rajesh Prasad Nunia of Chand Muni, Amtala Line, W/NO-47, PO+PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

I, ASI Dipak Kr. Chhetri of Matigara PS, Siliguri Police Commissionerate beg to state that on 01.01.2026 at about 23:10 hrs, I received a secret source information that a gang of miscreants were assembled at a vacant land opposite side of SJDA office at Himachal Vihar, PS- Matigara, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Himachal Vihar area, under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Bikash Roy, C/219 Sanatan Chitrakar, C/868 Sujal Roy and C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Himachal Vihar at a vacant land opposite side of SJDA office under Matigara PS to work out the information in hand. At about 23.20 hrs on 01.01.2026 we arrived at Himachal Vihar under Matigara in a vacant land opposite side of SJDA office under Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled in a dark place i.e vacant land opposite side of SJDA office at Himachal Vihar, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended five (05) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity at Himachal Vihar area under Matigara PS on 02.01.2026 night. They also stated that others 05/07 associates were able to fled away from the spot by taking advantages of darkness.

On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 23:35 hrs to 23:56 hrs on 01.01.2026. The whole process of seizure was made under videography and the video was made through WB E-Sakshya Application.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1] Md. Samir (21yrs approx), S/O- Md. Saidul of Tumba Jote, Beldangi, PO+PS- Matigara, Dist- Darjeeling, 2] Bishal Talukdar @ Bikram (27 yrs approx), S/O- Lt. Biswajit Talukdar of Sukanta Pally Gas Godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling, 3] Tarikul Islam @ Chhotan (24 yrs approx), S/O- Kalsar Alam of South Ambedkar Colony, PO+PS- Pradhannagar, Dist- Darjeeling 4] Joy Sarkar (30 yrs approx), S/O- Mahadeb Sarkar of Suryasen Colony, Block-B, W/NO-34, PO-Siliguri Town, PS- Bhaktinagar, Dist- Jalpaiguri and 5] Siddhant Prasad Nunia @ Subham (30 yrs approx), S/O- Rajesh Prasad Nunia of Chand Muni, Amtala Line, W/NO-47, PO+PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
