This is to inform your goodself that yesterday evening between 6:15 PM to 7:30 PM some unknown miscreants had entered our house after breaking the metal grill and looted the valuables and cash as per list mentioned below.

At around 6:15 PM I along with my wife and my kids had gone out for some work and came back at around 7:30 PM. On return we found that the back gate of the building was open, which we had locked while going out. After that we saw one of the windows of the room in the ground floor is also open and a part to the metal grill being cut. One of the wardrobes was open in the room. We immediately rushed to the 1st floor of the premises, all the wardrobes were open and every thing was lying on the floor. Valuable kept in the wardrobes were missing.
