Sir,

I, SMT. PUSPA ROY, Wife of Sri Mithun Chandra Roy, resident of Farabari, Bhelkipara, Sahudangi Hat, Binnaguri, P.O. Sahudangihat, P.S. Bhorer Alo, Dist. Jalpaiguri - 735135, would like to inform you that.

On 15.12.2025 at around 5.30 p.m., my husband came inside my room and as we were talking our conversation at some point escalated when the topic shifted towards his extra marital relationship, that he started shouting at me and the situation got so heated up that he grabbed my hair and slapped me in the face threw me on the ground and kicked me forcefully on my stomach. I being in pain and fear started shouting and after that he left the house premises.

I wanted to file a complaint right away but I had undergone a serious pain in my stomach and had to take some rest and a painkiller and the next day i.e on 16/12/2025 I went for a medical checkup in the morning but still i was in a pain, and again yesterday i.e. on 19/12/2025, i visited a doctor's clinic just because the pain was persistent and now that i am felling a little better, I am filling this complaint without any further delay as I am very scared and traumatized and in pain.

I therefore request you to kindly register my complaint as an FIR and take necessary legal action against my husband.
