This is to inform that We are running a Tata Motors showroom in the name of M/s Laksh Automobiles Pvt Ltd , today around 2.49 Pm some antisocial element namely Rafiq Hussain S/o Ajibaddin Md , Sarul Hoque and his father Sanarul Haque alias Bhochoch, along with a group of anti-social elements damaged our vehicles WB73N8229, WB74BV1932 and WB73D6896 and locked the main gate of our aforementioned Tata Motors Commercial Vehicle Showroom at Bandhunagar More, Mouza Ambari Falakata, PS: Bhorer Alo PS, district – jalpaiguri.

The above-mentioned miscreants along with their gang members not only threatened us with dire consequences but also caused injury to some of our employees, and anyone even trying to enter or leave the premises were being hit with stones , swords, iron rods and some dangerous iron equipment. They have deliberately attempted to damage our business and illegally encroach our land.

We along with more than 100 employees consisting of ladies and Men along with some customer of several age group are in a terrible We where unlawfully confined inside the showroom and any person trying to enter or exit the premises was attacked with stones and swords, creating a grave threat to life and safety. The accused persons namely Rafiq Hussain S/o Ajibaddin Md , Sarul Hoque and his father Sanarul Haque alias Bhochaque along with some other stood at the main gate and surrounding areas, preventing any sort of movement and creating panic among employees and customers.

The clear intention behind the violent act was to illegally encroach upon our land, these acts constitute serious criminal offences including vandalism, unlawful confinement, criminal intimidation and attempt to murder us and even asked for a ransom of Rs.10 lakhs on multiple occasions and also to grab portion of Our plot of land in RS Plot 150 whos total area of the Plot being approx area 84 decimal which is duely recoded in the name of one of the Director Mr Vishal Agarwal and My Wife Charu Agarwal and My nephew Ujjwall Agarwal , where there is also a injunction and status Quo granted by the Honble Court of Civil Judge Junior Division at Jalpaiguri District vide TS No 340 of 2019 and TS No 826 of the year 2025. We are regularly following up with Your Godself even Police doesn't come on time and takes few hours to reach the site of occurrence ,if Somethings happen to My or any of My family members or any employee Police department will be solely responsible.

Kindly please request you to do the needful as there is complete abuse of law and militancy like situation.
